Ann Davis, 222 Lewis St., we have a problem with water runoff, on January 26, 2012 we met with the Mayor, Engineer Schrek, and the water and mud down Pursell St., has been a mess since IR property put up the wall, I have contacted the DEP they say they only deal with contamination. No response from town on my OPRA request.

Council President Fey saw firsthand this past storm the water coming over the wall

Mayor Wyant the water should be coming off the sites and going into the catch basins, the rip rap is supposed to create a diversion and the half pipe off site down roadway has been told to me they have redirected the contour of the land to divert the water. We have to be careful once we excavate we can disturb the CAP.

Ann Davis asked about the ORPA request that her mom has completed and gets no paperwork on.

Attorney Wenner stated that the Shrubs / Trees from the IR have nothing to do with the Town that was all DEP oversight.

Ann Davis stated brown fields – and continual run off

Council President Fey – stated we are also dealing with a sink hole on Green St.

Mayor Wyant said the wall was installed under the direction of the DEP the Town instructed what type of wall would look best. We were offered just baskets with stone and Council said no they wanted something more decorative.

Ann Davis I have spoken to everyone at DEP, and I end up in the place put back here.

Council President Fey we hope to get it rectified and solve the problem

Ann Davis at what cost to my mom she is on a fixed income how much more can she spend.

Council President Fey stated we need to takes states to address this.

Ann Davis three (3) houses above her also something happening with them also

Attorney Wenner if you get a more detailed OPRA the town will try to respond.

Karen Grube – Thank you!

Floyd Levisay Valley View 56 years I have had gardens in the back yard will they be infringing on my property

Council President Fey there is no plan to reconstruct the property

Floyd Levisay stated when I have a cook out they be looking right at me

Council President Fey no strip mall,

Councilman Stettner ball fields, we don't have a buyer yet

Mayor Wyant said to Mr. Levisay that his gardens are on IR property

Floyd Levisay stated that he wanted to buy the land so he could have his gardens IR told me I could use it

Councilman Stettner stated NO DON'T GIVE UP YOUR GARDENS

Mayor Wyant also state NO DON'T GIVE IT UP WE are still looking for a developer
