This is a rental property where the tenant went away the pipes froze and broke and for days the water ran out the door. The sewer bill was quite high, he had a plumber repair it and in the last 12months his bill was \$77 was the highest went to \$1500.00 with the break I would like Council to give some consideration on that sewer bill.

Council President Fey not full payment we are open to suggestions

Councilman Tersigni said well maybe half of the bill

Mayor Wyant stated any consideration when the tenant left that is when the pipes broke.

Councilman Lynn questioned what did the water company do? Half is too much

Mayor Wyant stated that the water was used, the pipe broke didn't go through

Councilman Stettner stated that the way we used to do this is to go back to the usage of this place and to the average monthly cost.

Councilman Lynn went from 40 to 1500

Councilman Stettner stated that 176.46 was the highest so we can go back to the highest amount.

Councilman Stettner made a motion to go back to the highest average of \$ 176.46. Councilman Tersigni seconded the motion. The motion was carried with a 5-0 vote
