PUBLIC PETITIONS

Thomas Bush, Columbus Avenue, questioned sick leave granted to employees per year.

Clerk/Administrator replied 15 days.

Mr. Bush questioned whether days accumulate or do they lose those days if not used.

Clerk/Administrator replied accumulated.

Mr. Bush addressed the financial impact when employees retire.

Clerk/Administrator advised employees are paid for 55% of accumulated sick time.

Mr. Bush questioned Council whether they personally feel this is fair.

Blaine Fehley, 237 Bowhay Alley, addressed Access Committee and \$4,000 estimate.

Councilman Lynn noted when equipment was purchased approximately 8 years ago; the cost was approximately \$4,000.

Mr. Fehley questioned whether equipment can be used today.

Councilman Lynn replied no.

Councilman Lynn stated estimated cost for replace / repair of existing equipment is \$10,000. Personally, he continued he would not want to add \$10,000 to the budget.

Mr. Fehley noted Phillipsburg received \$47,000 franchise payment from Service Electric therefore; no problem in purchasing equipment.

Mr. Fehley addressed Access User Agreement forms and questioned why they do not exist.

Councilman Lynn replied he did not know.

Mr. Fehley questioned rules for him to come to the Access Committee.

Councilman Lynn referred to 'Public Access Rules and Policies'.

Mr. Fehley questioned reason he has been denied access to this channel and referred to comment that it would fall within OPRA.

Attorney replied it was stated that if he was sanctioned by the Town that the recording might be considered the official recording of the Town therefore; might be subject to OPRA laws.

Mr. Fehley complained that Council bios have not been updated. He noted each member should include their duties in their bio.

President Piazza replied his bio is updated as well as, Councilmen Fey and Stettner.

Mr. Fehley noted Mr. Lynn is not listed and Mr. DeGerolamo is still listed.

Mr. Fehley noted their email addresses are not included.

Mr. Fehley questioned manner in which survey for Access Committee would be conducted.

Councilman Lynn replied telephone.

Mr. Fehley referred to petition submitted with 450 signatures.

Councilman Lynn replied he would review information.
