**ORDINANCE OF THE TOWN OF PHILLIPSBURG,
COUNTY OF WARREN, STATE OF NEW JERSEY
AMENDING CHAPTER 67, "VEHICLES AND TRAFFIC,"
OF THE CODE OF THE TOWN OF PHILLIPSBURG**

BE IT ORDAINED by the Town Council of the Town of Phillipsburg, County of Warren and State of New Jersey, that Chapter 67, Vehicles and Traffic, of the Code of the Town of Phillipsburg shall be amended as follows:

Section 1

Section 67-11, *Bus stops designated; violations and penalties*, subsection (B) is deleted in its entirety, and replaced with the following:

The Phillipsburg Police Department is authorized to enforce violations of Section 67-11 of the Town Code, in accordance with such Ordinances and Statutes, in each case made and provided.

Section 67-13.1.1, *Right Turn Prohibitions for Tractor-Trailers*, is added as follows:

No tractor-trailer shall make a right turn at any of the locations described in Schedule XB, attached to and made a part of this chapter

Section 67-25.1.1, *Schedule XB, Right Turn Prohibitions for Tractor Trailers*, is added as follows:

In accordance with the provisions of §67-13.1.1, no tractor trailer shall make a right turn at any of the following locations:

Section 67-27, *Schedule XII, Parcel Pickups*, subsection (B), shall be deleted in its entirety, and replaced with the following:

The Phillipsburg Police Department shall be and the same hereby are authorized to enforce Section 67-27, Schedule XII, Parcel Pickups, in accordance with such Ordinances and Statutes, and each case made and provided.

Section 67-28, *Parking Lots*, subsection (A), is deleted in its entirety, and replaced with the following:

Off-street parking lots under the jurisdiction of the Town shall be by permit issued by the Town to cover the hours of operation established by the Town. The Gross Vehicle Weight (GVW) limit for any vehicle utilizing off-street parking lots under the jurisdiction of the Town shall be 10,000 pounds.

Section 67-28, *Parking Lots*, subsection (D), is amended to delete “parking authority” and in its place and stead the word “Town.”

Section 67-28, *Parking Lots*, subsection (E), is amended to delete “parking authority” and in its place and stead the word “Town.”

Section 67-28, *Parking Lots*, subsection (G)(1), is deleted in its entirety, and replaced with the following:

The Town of Phillipsburg shall have the authority to provide for the installation, regulation, control, operation, and use of parking meters and parking lots under the jurisdiction of the Town.

Section 67-28, *Parking Lots*, subsection (G)(2), is deleted in its entirety, and replaced with the following:

The installation of parking meters in an amount greater than 50% of the number of allocated parking spaces in parking lots under the jurisdiction of the Town of Phillipsburg shall require the approval of the Town Council of the Town of Phillipsburg.

Section 67-28, *Parking Lots*, subsection (H)(1), is amended by deleting the phrase “and/or the Phillipsburg Parking Authority.”

Section 67-31, *Parking Meters*, is hereby deleted in its entirety.

Section 67-38, *Duties of Police Officers and Special Officers*, subsection (A), is amended by deleting the phrase, “and designated employees of the Parking Authority, acting in accordance with the instructions of the Parking Authority.”

Section 67-42, *Enforcement*, is hereby amended to delete “Phillipsburg Parking Authority” and replace it with “Phillipsburg Police Department.”

Section 67-43, *Appointment*, is hereby deleted in its entirety.

Section 2 - Severability

The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 3 - Repealer

Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4 - Effective Date

This Ordinance shall take effect as required by law.
