ORDINANCE PROVIDING FOR CONSTRUCTION PHASE SERVICES FOR THE WASTE WATER TREATMENT PLANT UPGRADES AND OUTFALL RELOCATION BY THE TOWN OF PHILLIPSBURG, IN THE COUNTY OF WARREN, NEW JERSEY, AND APPROPRIATING \$390,000 THEREFOR FROM THE SEWER UTILITY CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PHILLIPSBURG, IN THE COUNTY OF WARREN, NEW JERSEY, AS FOLLOWS:

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Town of Phillipsburg, in the County of Warren, New Jersey. For the said improvement or purpose stated in said Section 2, there is hereby appropriated the sum of \$390,000.00 from the Sewer Utility Capital Improvement Fund.

Section 2. The improvement hereby authorized and the purpose for said appropriation is for construction phase services to be provided by Remington & Vernick Engineers for the Waste Water Treatment Plant Upgrades and Outfall Relocation Project, which project includes the relocation of the waste water treatment plant outfall piping system, modifications to the sequencing batch reactor basins, furnishing and installation of a BioMag™ treatment technology system, conversion of existing chlorination disinfection system to an ultraviolet disinfection system and all necessary site work. The construction phase services to be provided in connection with the aforementioned project consist of Basic Services, Construction Phase Engineering, Construction Inspection, Environmental Inspection, Contract Administration and One-year Certification, all of which are described more fully in the proposal dated

September 3, 2013 from Remington & Vernick Engineers and on file or to be filed in the office of the office of the municipal clerk and are hereby approved.

Section 3. The Sewer Utility Budget is hereby amended to conform to the provisions of this Ordinance to the extent of any inconsistency herewith.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.
