SEWER UTILITY CAPITAL ORDINANCE PROVIDING FOR THE PURCHASE OF A RAW WATER INFLUENT PUMP AT THE WASTEWATER TREATMENT PLANT, BY, IN AND FOR THE TOWN OF PHILLIPSBURG, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY; AND APPROPRIATING \$38,635 FROM THE SEWER UTILITY CAPITAL IMPROVEMENT FUND TO PAY FOR THE COST THEREOF

WHEREAS, the Town of Phillipsburg, in the County of Warren, State of New Jersey (the “Town”), wishes to purchase a raw water influent pump at the Town wastewater treatment plant, as shall be more particularly described in documents on file in the Office of the Clerk of the Town and by this reference incorporated herein (the “Capital Improvement”), by, in and for the Town; and

WHEREAS, the costs of said Capital Improvement is estimated to be \$38,635; and

WHEREAS, the Town Council desires to authorize an appropriation from the Sewer Utility Capital Improvement Fund in the amount of \$38,635 to undertake the aforesaid Capital Improvement.

BE IT ORDAINED AND ENACTED BY THE TOWN COUNCIL OF THE TOWN OF PHILLIPSBURG, IN THE COUNTY OF WARREN, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), **AS FOLLOWS:**

SECTION 1. The sewer utility capital improvement or purpose described in Section 2 of this capital ordinance is hereby authorized as a sewer utility capital improvement to be undertaken by the Town. There is hereby appropriated the amount of \$38,635 from the Sewer Utility Capital Improvement Fund for said improvement or purpose stated in Section 2 hereof.

SECTION 2. The sewer utility capital improvement or purpose hereby authorized is the purchase a raw water influent pump at the Town wastewater treatment plant, as shall be more particularly described in documents on file in the Office of the Clerk of the Town and by this reference incorporated herein and also including all work, materials, equipment, labor and appurtenances necessary therefore or incidental thereto.

SECTION 3. The Mayor, Chief Financial Officer and any other official/officer of the Town are each hereby authorized and directed to execute, deliver and perform any agreement necessary to undertake the improvement of purpose set forth herein and to effectuate any transaction contemplated hereby.

SECTION 4. The sewer utility capital budget of the Town is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, is on file in the office of the Clerk and is available for public inspection.

SECTION 5. Capitalized terms used herein and not otherwise defined, shall have the meanings ascribed to such terms in the preamble to this capital ordinance.

SECTION 6. This ordinance shall take effect in accordance with applicable law.
