**A RESOLUTION OF THE
TOWN OF PHILLIPSBURG, COUNTY OF WARREN,
STATE OF NEW JERSEY, AWARDED CONTRACT
TO WORTH AND COMPANY IN THE AMOUNT OF \$47,253.00**

WHEREAS, the Town is the owner of the Municipal Building located at 675 Corliss Avenue, in the Town of Phillipsburg, Warren County, New Jersey; and

WHEREAS, there exists the need to have mechanical maintenance contract, for the municipal building, senior center, and the library; and

WHEREAS, the Town set forth specifications for the Project; and

WHEREAS, the Town advertised for competitive bids; and

WHEREAS, said advertisement was for a three (3) year service contract; and

WHEREAS, the Town received a total of two (2) sealed bids; and

WHEREAS, the Town opened sealed bids on February 05, 2014 at 11:00 a.m. at the Town Hall; and

WHEREAS, Worth and Company was the lowest responsible with an aggregate bid price for the three (3) years of \$49,509.00.00; and

WHEREAS, said bid on a yearly basis equates to the following:

1. 2015 \$16,503.00
2. 2016 \$16,503.00
3. 2017 \$16,503.00; and

WHEREAS, the bids were reviewed by the administration and by the Town Engineer with a recommendation to award the bid to Worth and Company as being the lowest responsible bidder; and

WHEREAS, a Certificate of Availability of Funds has been issued by the Chief Financial Officer of the Town of Phillipsburg for the year 2015; and

WHEREAS, funds for the years 2016 and 2017 will be available through appropriation in the municipal budget; and

WHEREAS, the Town is desirous of awarding said bid.

NOW THEREFORE IT BE RESOLVED by the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey, that the Town Council does hereby award the bid for the Maintenance to Worth and Company in the amount of \$49,509.00 in accordance with the bid and bid specifications submitted therefor.

BE IT FURTHER RESOLVED that the Mayor and Acting Municipal Clerk are hereby authorized to enter into a contract on behalf of the Town of Phillipsburg upon the submission of all proper documentation by Worth and Company pursuant to said bid.

BE IT FURTHER RESOLVED that the Mayor and CFO are hereby directed to make the necessary appropriations in the municipal budget for years 2016 and 2017 sufficient to effectuate payment of the contract as set forth above.
