**A RESOLUTION OF THE
TOWN OF PHILLIPSBURG, COUNTY OF WARREN,
STATE OF NEW JERSEY, AWARDED CONTRACT
TO Z BROTHERS CONCRETE CONTRACTORS, INC. IN THE AMOUNT
OF \$379,999.82 FOR MAIN STREET PHASE 7**

WHEREAS, the Town advertised for sealed bids to be submitted in connection with the Main Street Improvements, Phase 7 (the “Project”); and

WHEREAS, the Town set forth specifications for the Project; and

WHEREAS, the Town received a total of three (3) sealed bids; and

WHEREAS, the Town opened sealed bids on June 16, 2015 at the Town Hall; and

WHEREAS, the bidders were:

1. Your Way Construction, Inc.
404 Coit Street Irvington NJ- \$382,280.77
2. Z Brothers Concrete Contractors, Inc.
304 James Mill Road Sayreville NJ- \$379,999.82
3. Vektor Corporation, Inc.
PO Box 6892 Monroe, NJ \$364,949.50;

and

WHEREAS, the bids were reviewed by the administration and by the Town’s Professionals; and

WHEREAS, Vektor Corporation’s bid submission was materially deficient due to, *inter alia*, the failure to provide business registration certificates of its subcontractors and failure to fully identify its subcontractors; and

WHEREAS, Z Brothers Concrete Contractors, Inc was the next lowest conforming bid and the a recommendation has been made to award the bid to Z Brothers Concrete Contractors, Inc. as being the lowest responsible bidder; and

WHEREAS, funding is available as evidenced by the attached Certificate of Availability of Funds; and

WHEREAS, the Town is desirous of awarding said bid.

NOW THEREFORE IT BE RESOLVED by the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey, that the Town Council does hereby award the bid for Main Street Improvements, Phase 7 to Z Brothers Concrete Contractors, Inc. in the amount of \$379,999.82 in accordance with the bid and bid specifications submitted therefor.

BE IT FURTHER RESOLVED that the Mayor and Municipal Clerk are hereby authorized to enter into a contract on behalf of the Town of Phillipsburg upon the submission of all proper documentation by Z Brothers Concrete Contractors, Inc. pursuant to said bid.
