**A RESOLUTION OF THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN,
STATE OF NEW JERSEY, AWARDED CONTRACT
TO AROLD CONSTRUCTION CO. IN THE OF \$316,350.00**

WHEREAS, the Town is the owner of a Wastewater Treatment Plant (“Plant”) located at 900 South Main Street, in the Town of Phillipsburg, Warren County, New Jersey; and

WHEREAS, the Town operates the Riverside Way Force Main & Sewer Gravity Main (“Pump Station”), which Mains have deteriorated and are in need of repair; and

WHEREAS, there also runs a Stormwater Main alongside the Force and Sewer Mains which is also in need of repair; and

WHEREAS, the Town’s Sewer Engineers determined the best way to address the foregoing was to have the Force and Sewer Gravity and Stormwater Mains repaired by use of slip lining same (the “Project”); and

WHEREAS, the Town set forth specifications for the Project and provided for a base bid for the repair of the Sewer Mains and an alternate bid for the repair of the Sewer Mains and the Stormwater Main; and

WHEREAS, the Town advertised for competitive bids; and

WHEREAS, the Town received a total of two (2) sealed bids; and

WHEREAS, Arold Construction Co. was the lowest responsible with a base bid price of \$198,350.00 and an alternate bid of \$316,350.00; and

WHEREAS, the bid was reviewed by the administration and by the Town Sewer Engineer with a recommendation to award the alternate bid in the amount of \$316,350.00 to Arold Construction Co. as being the lowest responsible bidder; and

WHEREAS, sufficient funding is available as evidenced by the attached certification of funds; and

WHEREAS, the Town is desirous of awarding said bid.

NOW THEREFORE IT BE RESOLVED by the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey, that the Town Council does hereby award the bid for the Project to Arold Construction, Co., in the amount of \$316,350.00 in accordance with the bid and bid specifications submitted therefor.

BE IT FURTHER RESOLVED that the Mayor and Municipal Clerk are hereby authorized to enter into a contract on behalf of the Town of Phillipsburg upon the submission of all proper documentation by Arold Construction Co. pursuant to said bid.
