### MAYORS REPORT

The DOT grant for phase 6, for 237,000.00 to do Mckeen to Center is not the entire amount, we put money into the capital budget sometime in late summer early fall, next year Center to Saw Mill that will complete South Main Street.

Recently we have done away with the Planning and Zoning boards and combined their duties I have a member as an Alternate member for a one (1) year term if Council appoints. Motion to approve Keith Zwicker as an alternate was made by Councilman Stettner. Councilman Lynn seconded the motion.

Tonight we have Georgine Trinkle with is and also Chief Faulborn, once a quarter progress report. The reading room has been moved to the housing authority property, we have 11 children Saturday that stay the entire time along with an officer there as well.

The Community Service Project 25,000 youth deterrents community service 25 juveniles that have station house adjustments that deter incarcerations for at risk youth and they teach leadership programs.

We will be doing graffiti removal May 17 from 1-4 at Delaware Park, all are invited to give us a hand.

The Chief has done an internal assessment of the Community Policing – he participated in training and crime evaluation it is working

The Chief stated that he had an open house last Saturday and had 75 people show up, He was surprised they toured the HQ and squad room, crime scene van and learned about solving crimes. They met two of the newest officers, Marino, Mecca. We got information for people to know who their community police officer is.

Warren County / Sussex County applied for a vehicle Tactile – we are hoping the Warren County Freeholders would act on it, and they are not acting on it. I am

asking for the Governing Bodies support on it. I addressed the Freeholders and Prosecutor Burke asking for their support.

Councilman Stettner questioned – years ago there was a grant - thank you for all your work

Georgine Trinkle can be fast five (5) years

Councilman Stettner Thanks and please thank your staff

Georgine Trinkle grant due four (4) hours it's a risk for open house to get the residents involved and give the police an opportunity to meet the community.

Councilman Fey looking forward to the Community Policing how much involvement and didn't expect the support and it has taken things to a new level, thank you both for your great efforts.

Chief Faulborn we have had saturation patrols, we are in the assessment phase so see what the problems are, how to solve them, reevaluate them and get out on foot.

Chief Fairborn's monthly stats – handed out to the Mayor and Council The Chief stated that they are working on additional cameras in various areas down town. We are working to make Delaware park safer, hope to have the dog park by next summer-an improved park to be better utilized

Mayor Wyant stated the Dog Park was approved by green acres, we have to work on the Ordinance and make changes so dogs will be in certain areas of that park fencing must get done and so fourth

Chief Faulborn stated that was all done by Officer Deluca he took that on his own

Mayor Wyant stated he has done a lot of work and should be commended for all the work he has done, he even has model ordinances that he turned to the Town Attorney and I commend him for that. Officer Deluca will watch it, police it and with a competent ACO it is a good thing

Chief Faulborn I look forward to it. I wasn't sure how it was going to work thanks to the Mayor and Council Thanks...

Council President Tersigni asked how many cameras are you going to be adding

Chief stated six I believe

Mayor stated on Friday the 16<sup>th</sup> at 10:00 am we are having an auction with Maxx Spann – for the Chamber Street Property hopefully it sells we have had renewed interest.

On April 23 we had 296 properties for tax sale, and collected \$346,100.00 we held 10 certificates that didn't sell, so we may have to start foreclosure on them. Thanks Mayor

# HABITABILITY HEARING

Attorney Wenner stated that notification was sent on 04-17-14 signed acknowledgement receipt; we called and were told he would be here.

Mr. Duddy to report on the status of the property and water tower, since the water tower has been removed last fall there has been damage to some structures due to the weather in late February the snow load made the roof collapse.

Mr. Hernandez received information about the unsafe structure on February 24 and again on March  $3^{rd}$ , he had till May  $16^{th}$  to demo the roofs . He was notified of the building being an unsafe structure of he does not comply by May 16, 2014, he will be fined \$500.00 / week. Summons every week to Municipal Court.

Attorney Wenner stated that's about 10 days from now to comply. We will have an update at the May 20 th meeting. If not show Mr. Duddy will enforce and the Council will determine the next step

Council President Tersigni this is the last chance to address Council, In my opinion, I believe it should be demolished.

Mr. Duddy the building is unfit ordinance has worked well

Chief Faulborn stated the Fire police can open the Street for emergency vehicles

Attorney Wenner stated that they are doing what required

Adam Kita 356 Firth Street, I have been on the squad, I coached recreation for Firthtown, Steele Hill, Pal, I was on the Planning board and I believe in giving back to the Town and not the Town getting taken advantage of.

I understand the spirit of the PILOT to help industry out and good paying job, I travel 120 miles a day to Kearny, I know that the Rutgers study may not be accurate. Phillipsburg has affordable housing, beautiful high school, I see parents

looking to move into our Town. But sometimes the Candy coating is sweet on the outside and you get a sour ball on the inside, I am sure the tax payers will pay the price somewhere. But I wanted to bring my point forward I am very confident you all will make the right choice. Thanks for your time.
