PUBLIC PETITIONS

Patty O'Neil, 53 Schultz Ave., would like the house next door to her 57 Schultz Ave., to get cleaned up, grass, garbage, baby seat on the porch, and trampoline in the yard. Mayor Wyant explained to Mrs. O'Neil that the Town can't just remove personal belongings from the property, only debris that's in the yard. Mrs. O'Neil wants the banks to foreclose and sell, so people can buy the houses and maintain them. She is very disgusted with the amount of abandoned houses in her Phillipsburg.

Mary Knauth, 269 Irwin St., lives in half a double had mold in her basement the other half of the double 271 Irwin has been empty for months, she is worried that there is water in the basement, carpet also which when wet grows mold, and she paid over \$8,000.00 to have her side made mold free and is concerned that it could spread. She said that 271 Irwin St., owners removed all the kitchen appliances, cabinets to sell, concerned that people who may be interested in buying would have a lot of work to do.

Louis Cartabona, 1119 Fifth Ave., Alpha, mentioned that the Town can go into the house at 271 Irwin St. with an "acting emergency", Pending a threshold of mold penetrating into the house.

Mr. Cartabona applauded the Town of Phillipsburg for being aggressive in handling the overgrown grass issues in Phillipsburg.

Blaine Fehley, Bowhay Ave., questioned again at whose discretion on whether or not to keep a board member whose background check came back questionable. The Town Council replied that it is up to the Board that the member is on.

Mr. Fehley questioned the situation at the Ice House, with the roof that fell in and overgrown grass. Councilman Fey stated that the Town Inspector, Mr. Duddy, went out to the property. Contacted the owners who stated the property is in the middle of being sold but the owners are still being cited for property maintenance.

Mr. Fehley said that they are still kids getting into the building on Stockton St. and doing gang related graffiti inside. The owner of the property Mr. Capozzo was well aware that the kids were inside his property he removed the plywood door for them to enter. Mr. Fehley was concerned that the kids removed the door themselves and shoes were hanging over the wires on that street. A neighbor shed was spray painted and Mr. Fehley wants the graffiti removed, Council stated that graffiti inside a building is not under the Ordinance. Mr. Fehley stated he could see the graffiti inside the house from the outside so it should be removed. Attorney Wenner stated that only the outside of the buildings can be cleaned from graffiti as per the Ordinance. The inside was they owners choice how it is painted.

Mr. Fehley questioned the Attorney how many days for an OPRA response. Mr. Wenner response was seven (7) days.
