# HABITABILITY HEARING 475 South Main Street.

Attorney Wenner said that at the last meeting an order was issued with the lien holders that the debris and brush on the common alley be removed. The lien holder was advised of the hearing tonight.

Attorney Wenner asked Mr. Duddy to tell the Council about the status. Mr. Duddy stated that he posted the property owned by Empire TF2 Jersey Holdings, LLC, and no one has contacted me.

Attorney Wenner asked Mr. Duddy if the structure a concern for the health, safety and welfare of the residents of the Town of Phillipsburg?

Mr. Duddy said that he hasn't been inside, he went to Toms Lunch and it was closed on Monday. The exterior needs to be cleaned up immediately the plywood that is barricading the alleyway has a lot of debris behind it even a vending machine and looks like there are items in it.

Council President Tersigni passed out photos of the debris. The Mayor took the photos.

Attorney Wenner questioned if the Mayor took the photos

Mayor Wyant stated yes I did.

Attorney Wenner stated can you explain the photos

Councilman Piazza questioned Mr. Duddy have you been inside looks like a fire hazard.

Mr. Duddy stated it definitely is a fire hazard from lack of the house keeping

Councilman Fey said what action can be taken inside

Attorney Wenner stated that Kevin has the authority to enter with Dennis Viscomi – Superintendent of Public Works to check the building status

Mr. Duddy stated that he will go into it and padlock the door; he stated he will give the Council a report by the next meeting. I will take photos inside.

Mayor Wyant stated that there is a lot of debris in between the buildings and the stairway to the second floor has been removed, I don't think there is access to the second floor. The roof is in total disrepair, the roll roofing is pulled back and allows water to enter the building, and clearly this is a problem area

Attorney Wenner stated that they were given the 10 days with The Town of Phillipsburg to remove and add a lien for the cost to remove the debris Council can request it to be done.

Councilman Lynn asked can we do that by motion

Mayor Wyant said there is a new law that adds penalties

Attorney Wenner stated that the new law allows for lienholders to be issued summons, the Town can go against the title holder and the bank. Empire TF2 Jersey Holdings, LLC is the title no bank if Council wishes to direct – we can do so.

Mr. Duddy, I will get together with Dennis Viscomi

Attorney Wenner added the Council can direct Mr. Duddy to inspect and August  $5^{\text{th}}$  we can bring it back to Council.

Councilman Piazza states I think we need to do – what we need to do – also get property owner in here.

Councilman Lynn I think we need to clean up the outside, and we know there is debris inside can we penalize for what is inside

Attorney Wenner said we can't until Mr. Duddy goes inside

Mr. Duddy, I'll take photos and report back to Council, on August 5<sup>th</sup>.

Councilman Lynn makes a motion to have Mr. Duddy go in and inspect and bring Empire TF2 Jersey Holdings, LLC., In on the August 5, 2014 meeting. The motion was seconded by Councilman Piazza.

## MAYORS REPORT

Well today I signed the contract for the shared services with the Court, Council President of Alpha signed as well and we will be starting August 01, 2014. It should be advantageous to Alpha as well as Phillipsburg.

I also have two petitions from the office staff and DPW requesting that December 26, 2014 and January 2, 2015 that we close the building. The employees would have to use their vacation day for that day.

Councilman Piazza questioned if that is a Friday?

Councilman Piazza made a motion to close for those two days during the holiday and the employees must use a vacation day. The motion was seconded by Councilman Fey.

The Mayor stated that he also met with the Firthtown and Steele hill youth groups regarding the insurance, because they are not part of the Town of Phillipsburg the discussion was to bring the youth groups under the auspicious of the Town of Phillipsburg. Firthtown and Steele Hill both have a binder now; we are working on something to avoid having the youth groups pay \$8000.00 a year for insurance.

Attorney Wenner stated that extending to the Youth Organizations and bring it under the direction and control of the Town of Phillipsburg – control under the Department of Recreation. We had a conversation with John Moore the Broker for the Willis Group. There are a host of other issues, procedurally, and operatively to dissolve the 501 3 C and give up identity and to understand what that means. Individual – Control we need to have full disclosure for all parties involved.

Mayor Wyant said we should sit down with the actual criteria with the youth groups again. The Insurance carrier states we must have some control

Attorney Wenner stated more control that what's just on paper and not hurt the Town of Phillipsburg, but it could hurt the youth organizations

Councilman Fey questioned if the Youth Groups will lose their non- profit status

Attorney Wenner were non profit

Mayor Wyant stated it will come under our direction

Councilman Fey said it should help with communication, like assisting cutting the grass

Mayor Wyant said that it will be similar to the Senior Center, have their own board, the board does what they want but under the control the arm of the Town of Phillipsburg

Councilman Lynn so the leadership of the town changes and so can the director of recreation change. Dawn retires we get a new director and makes decisions to make changes how can we keep things from constantly changing

Mayor Wyant stated that they can always opt out

Councilman Lynn so we can take individually

Mayor Wyant stated it is a valid concern and the unknown is hard to predict

Councilman Lynn stated it is our responsibility to look ahead to help the process the future

Mayor Wyant stated that he didn't bring the soccer group in, so I will have to see if they're interested in doing this also.

Attorney Wenner stated I will have my information put together and research it fully for the Town and the Youth Organizations as well

Mayor Wyant stated that we need to discuss this more before decisions are made

Attorney Wenner stated that we own and maintain the fields what liabilities

Mayor Wyant stated that they are covered under liabilities coaches are not protected now from being sued

Council President Tersigni but it would be less expense for the youth groups

Mayor Wyant stated that they pay \$8000.00 now and they would pay nothing, but there is hesitation when you say control, I don't blame them they have done a fine job over the years. Same money with least amount of control

Councilman Fey stated both organizations are in agreement

Mayor Wyant stated individually organization – in are fine or out is fine were making the offer, but we don't know what the offer is yet. If I was in their shoes I wouldn't want to agree until I know what I am agreeing to

Mayor Wyant also spoke about 90 Sitgreaves Street, that is burnt out and in foreclosure, we need Council to take a look at and the lienholder to see if they are going to fix it or tearing it down.

Attorney Wenner stated that Kevin issued an unsafe structure 45 days

Mayor Wyant we need to verify and you did then search

Attorney Wenner yes

Mayor Wyant stated we can't allow the building to remain in this condition

The Chief stated that Captain Stettner received a grant Youth in Community we were the only Police Department in the State to get it. The Station house adjustment program, it is structured to task thru the Town

Mayor Wyant stated that the 700 block of South Main Street found nothing do you have anything to report on this

Chief stated the odor investigation concerns that there was drug activity but there was none found, the fire, health, and hazmat and squad found nothing of danger, we had a review Monday morning, Criminal investigation and there was no evidence of hazardous material, we erred on the side of caution and we reviewed the areas we need to work on

Mayor Wyant said good news it was nothing, it could have been worse and it is better to error on the side of caution but no disaster.
