MAYORS REPORT

The Mayor introduced Georgine Trinkle from NORWESCAP and the Chief to speak about the upcoming events.

Georgine Trinkle reminded Attorney Wenner that he said he would run along with the Cops on the run 5 K for the Community Police Partnership. Tuesday, August 4th is National Night Out. It is an annual event we have some special things planned. Don't worry Mayor not a dunk tank; there was a suggestion last year with the traffic flow. Problem solving initiative, it is a party with free food. I will need to come in at a later date to talk about the Federal funding complete assessment, line officers and line staff. The Town of Phillipsburg compared to same size agencies we have 100% participation of the police department, every supervisor and staff member did this.
