## MAYOR'S REPORT

#### Tibbett & Wood Property

<u>Robert De Beer</u>, Development Director for Peron Construction, advised contract has been entered into for demolition of property. He reported work should be completed within the next 45 days.

Mr. De Beer indicated property is very difficult to secure but is hoping once property has been demolished that a lot of the activity at this site would cease and it would become more manageable.

#### Warren County Prosecutor

Mayor stated he has received a request from Chief Faulborn that a passenger van owned by the Town that we no longer need be transferred to the Warren County Prosecutor's Office for use by the Tactical Response Team.

James Faulborn, Police Chief, stated that the Prosecutor has given the Town vehicles, which they no longer need.

President Piazza directed item be placed on February 21 agenda.

# Police Department

James Faulborn, Police Chief, presented January Monthly Activity and Mileage Reports.

Chief Faulborn stated he would publicly like to thank members of his department as well as, Warren County Prosecutor's Office, Pennsylvania State Police and Allentown Police Department for their work on the recent homicide. In addition, he commended the Criminal Investigation Unit and the Patrol Division for working very hard together in resolving this horrific crime.

President Piazza commended Police Department for their due diligence on that homicide investigation.

Mayor extended to the department and the outlaying departments his sincere gratitude for all their hard work and dedication in solving this crime. He stated this is what it is all about...working together. Further, he noted it is commendable and must be recognized.

Councilman Fey extended his appreciation for all their work.

Councilman Tersigni stated it was a great team effort and believes they should be commended. He stated that it sends out a message that they will not get away with that in Phillipsburg.

Chief Faulborn advised that Mr. De Beer has provided letter regarding trespassing on Tibbet & Wood property therefore; patrols will be directed to enforce.

### Surveillance Cameras

Mayor advised that he and Chief Faulborn met with a representative from Northeast Surveillance and Alarms and during that meeting, toured the Town to explain what they were trying to accomplish.

Mayor referred to discussion with Attorney regarding establishments open after certain hour or 24 hours being required to have surveillance, which he was advised Town could not require.

Attorney noted it would be considered delegation of police powers and it is unlawful to force private homeowners to take on that power. Possibly, Attorney continued the Town could offer some type of incentive for those who did install cameras.

Councilman Stettner provided Municipal Webcam Surveillance information for Council's review.

Chief Faulborn stated Northeast installed system in Hazelton and suggested it might be worth a trip to see what they have done.

Mayor indicated complaint would be filed with Inspections Department with an Inspector visiting property to make recommendations and to issue summons if property owner does not comply.

Mr. Fehley questioned how a Municipal Lien is placed for work performed by Town employees.

Mayor indicated Council adopts resolution placing lien against property.

Mr. Fehley questioned who is responsible for bill.

Mayor indicated Public Works Superintendent certifies cost; bill prepared by secretary and forwarded to property owner. If bill is not paid within period of time, Mayor continued Council is requested to authorize lien against property.

Mr. Fehley addressed 11 John Street and noted it took employees 2 hours and 10 minutes to perform work but bill reflected 2 employees; 4

hours; vehicles for total cost of \$600. He noted that his neighbor has provided a statement verifying time spent on property.
