AN ORDINANCE OF THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN, STATE OF NEW JERSEY, AMENDING SECTION 422-11, USE OR POSSESSION OF LIQUOR, USE OF TOBACCO, OF THE CODE OFTHE TOWN OF PHILLIPSBURG TO PROHIBIT THE SMOKING OF TOBACCO IN ALL PARKS AND AT ALL RECREATION OR ATHLETIC FACILITIES OWNED OR LEASED BY THE TOWN OF PHILLIPSBURG

BE IT ORDAINED by the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey, that Section 422-11, *Use or possession of liquor, use of tobacco*, of the Code of the Town of Phillipsburg, is hereby deleted in its entirety and in its place and stead replaced with the following:

- §422-11. Use or possession of liquor, use of tobacco.
 - A. No person shall drink, take, use or have in his/her possession any intoxicating liquors in any park, playground or other recreational areas.
 - B. The smoking of tobacco products, including electronic cigarettes, in any park or at any athletic or recreational facility owned or leased by the Town of Phillipsburg, including parking lots attached to same, is prohibited.

Section 2:

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder off this Ordinance shall not be affected thereby.

Section 3:

<u>Repealer.</u> Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4:

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.
