# MAYORS REPORT

Mayor Wyant asked CFO Robert Merlo to discuss with Council the Best Practices 2015. Robert Merlo spoke about the Best Practices survey and that it determines how much of the municipalities final 5% allocation of State Aid will be disbursed. It also encourages you to promote financial accountability and transparency in the Municipality. There are 50 questions, five that were new in 2015; the survey is broken down in to six categories, budget, finance, health insurance, personnel, general management and procurement. All questions are answered yes/no, but some questions have a not applicable or perspective. In order for the municipality not to have a penalty from state aid payment they must score a 41 or higher, this year we had 43 out of 50 and no reduction in funding we will get 100%. Last year we had some perspective questions this year we had none. Last year we answered seven with a no answer, this year we answered no to the same seven questions. Council President Lynn do you feel we should look at that

Robert Merlo stated yes for example the bargaining negotiations discussion Council President Lynn so there is some room

Robert Merlo yes we are in a good position to get all the funding this year Mayor Wyant stated same questions to every municipality – they should be tuned to each municipality, some questions don't pertain to us, then we don't get to 100%

Robert Merlo if you reach 100% I am sure they will look at you, we are in good shape we had 43 yes's this year and last year.

Councilman Piazza questioned what action can we as a Governing Body addresses these issues?

Councilman Stettner stated as question #23 the Pay to play, verbiage is not correct Attorney Wenner stated it is not realistic for some municipalities especially

Phillipsburg. The non-contractual employees, PBA, are governed by Civil Service. Elimination of health Benefits have conversation now.

Robert Merlo if yes and approximate dates discussed are also being asked.

Attorney Wenner stated this Administration and Council discusses, not eliminating longevity- the SOA, no long percentage base but we need to take baby steps start with new hires.

Councilman Stettner stated it falls within the scope

Robert Merlo if you do offer – have you increased longevity

Attorney Wenner we have taken steps to reduce

Mayor Wyant stated we have had discussions with SOA and it went NO where – but we complied.

# MAYORS REPORT

Mayor stated that in 2006 and 2007 - 142 Broad Street through habitability hearings this property was listed on the abandoned and blighted properties list.

I would think that Councilman Stettner would probably remember this, now we have an individual who wants to purchase it and take it off the blighted and abandoned property list.

Attorney Wenner stated that the title company can see on a search. Bill Eddelston would like the complaint to be removed from the record of title so they can get a clear title. I can draw up a resolution doing so but be held in escrow till closing occurs, because if we do prior to closing and it doesn't occur

Councilman Stettner questioned if there are any liens

Attorney Wenner stated no

Mayor Wyant said he wants it held in escrow

Attorney Wenner stated that resolution 2015-170- removal cancelation of abandoned property, removal of unfit buildings list contingent of pending closing.

Council President Lynn questioned what guarantee

Mayor Wyant stated the property owner rather than the bank that lives there and will rehab the property, it is have eight or nine years dealing with this property, they need to fix it if not they will be brought back to Council

Councilman Piazza stated we still have to inspect it

Councilman Fey stated perspective buyer lives in Town now

Mayor Wyant stated he reached out to Attorney Eddelston who has a perspective buyer.

Attorney Wenner stated he will need a for a motion for R2015-170 to authorize 142 Broad Street, Block 206, lot 5 to be discharged compliance of fitness of said property upon closure.

## NEW BUSUSINESS

Council Vice President Tersigni would like to propose an ordinance on Bed Bugs, we had a situation on Dugan Alley with the DPW and they can't take the mattresses away. The property owner and the tenants need to be responsible \$500.00 fine hope the judge to enforce it in 10 days after that the summons should be \$1,000 fine. In 2012 I started this "War on Garbage" It has made a better quality life to the Town of Phillipsburg. This Ordinance should be drawn up immediately and we can nip this in the bud, every complaint I have filed I have won. This bed bug thing will send a message that the property owner needs to be accountable. Attorney Wenner stated he will do a draft.

Council President Lynn stated after the inspection of the HS they didn't' find anything (bed bug wise) but this issue needs to be addressed, Councilman Tersigni was right there and we commend you.

Attorney Wenner stated that when people empty apartments they put out for the Town, if it is known of presumed the property owner is noticed. They must get a private hauler. Under the State Law the infected items must be wrapped in plastic and sealed.

Mayor Wyant stated the ordinance will put people on notice, one of our DPW took home bed bugs and it was devastating to the family, it is not something were going to subject our employees too.
