Council Vice President Tersigni said there is a big difference that it did not go down the sewer. Council President Lynn voted differently in the past, depending on if went down the sewer or not.

CHIEF

Chief handed out his stats, 141 hours of community policing, zone 1 reports of people not stopping at the stop sign. zone 2, traffic issues Filmore and Hudson streets, zone 3 parking complaints, zone 4 no complaints down town area.

The Chief stated that the fall festival continued to grow, the bounce house on Jersey Street went well, tonight we have coffee with a cop and we are going into the neighborhoods. Tonight is Heckman house and bingo. The 12th we are going to do it I can't recall where and the 14th is here at the Town Hall.

John Franceschino spoke about the big success of the fall festival, we had about 600-800 peo0ple, the hay rides, we had a big showing. The chapel program date and time to meet, we had a good turnout of clergy. Mayor Wyant suggested that we have them swore in to kick off and show that they are supported by Council and the Mayor. Chief stated that the County has a faith base level.

Mayor Wyant stated there are not as far as you are here. John Franceschino stated 6-7 Pastors from our area it is a great program. Chief stated NJ has been very successful – police commitment – it will benefit everyone.

Council President Lynn great place to introduce to the community Councilman Piazza questioned the amount of stats and that what is the number of Domestic abuse and alcohol related cases are there.

Chief stated the number is up significantly 70-80%

Councilman Piazza when officer goes it is the most dangerous, are there ever any resolutions to the situations

The Chief stated that there is a restraining order, but the go back to the abuser, there are programs, we do work with DARC center, and the majority of victims turn it down. It is very frustrating John Franceschino stated that our crime survey is complete DCJI, 2011 Domestic the biggest most frequent call; we have more domestic than any other calls.

Councilman Fey stated that the grants, Marino, Deluca, Stettner this Town is lucky to have something for our kids. Chief stated Georgine is a catalyst and fortunate for educated people.

Council Vice President Tersigni asked if they could put the speed sign at Heckman Street, cars speeding down 70 mph please put the sign by Finnegan's Funeral home. John Franceschino stated he can show the data of the speed machine if he wants to come in and see it. Thanks Chief.

OPUS PRESENTATION

Joe Baumann spoke as Counsel for OPUS, here is an update so far, and the impact study is complete. The park, playground, and all roadway impacts are done. The GD permit, is completed and the next planning board meeting it will be memorialized. The DEP and DOT are on board. We have a signed agreement with IR and the bank property, to promise to buy the land, extensions payments and closing, the first quarter next year. Lopatcong is similar, no official actions hopefully in December.

The next step is the financial agreement, PILOT competing with Pennsylvania rates. 3.75-5.50 per sq ft. 4.50 sq ft. taxes vs PA (Pennsylvania), paying .10/tx vs .45 tx. Makes us competitive. Consider the PILOT 1.2 million in tax once built out. The land taxes gets shared with the school and county. Agreement by Ordinance, special assessment ordinance, 2.5 million dollars as in bonds we hold, ratify the

sale by an Ordinance. December 15th authorize to issue redevelopment bonds. 4.5 cents to RAB (redevelopment area bonds) what with need and difference, and Non-recourse to the Town of Phillipsburg. The local finance boards (LFB) bless the resolution, PILOT go up every year and goes up by 2% and a 2% cap keeps pace with expenses. We have a detailed application, that Attorney Wenner, Tony Panella (Special Bond Counsel), share and advise you. Discuss with your professionals in the next two weeks.

Council President Lynn that is a lot to be taken in, the next two weeks, next meeting can we have paper so we can review.

Joe Baumann yes of course

Council President Lynn the quicker we get that the quicker we can review Councilman Fey the competing state – and a draw to NJ is a credit to the Mayor and Council to learn from their successors and do things in a pace that is successful Council Vice President Tersigni 2.5 million bond ordinance isn't it in place Joe Baumann stated it is debt equity and RAB, 2.5 million, 30 years, part money comes from the County share.

Mayor Wyant we have been through this a couple of meetings, Tony I would like you to come into executive session with us.
