- You must be able to carry on all items in ONE trip

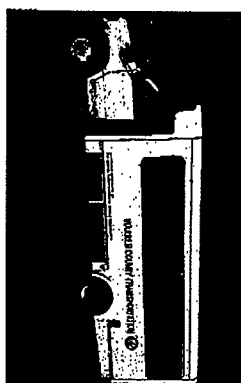
## SERVICE INFORMATION

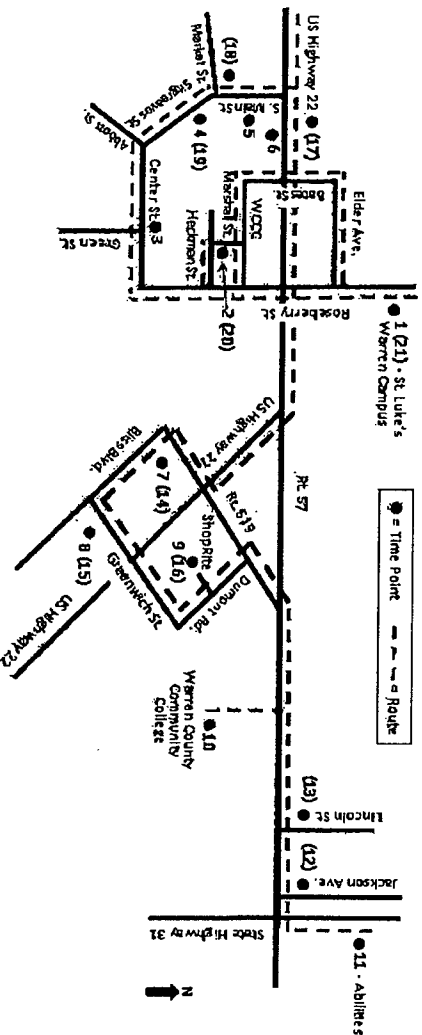
