PUBLIC PETITIONS

Joe Meyner, 392 South Main Street, on the agenda for October 17th there was an Ordinance 2017-25, authorizing 1.9 –two million dollar limit – what happened to that bond ordinance?

Council President Tersigni stated that the previous administration lowered the debt service and that he wasn't going to vote for this. It has been tabled.

Bill Timmann, 230 South Main Street, I am going to bring this up again. The cable service and the cost of the services. There is no progress – no way to get service electric to do better service or get another service. Councilman Davis responded as have access to it but no equipment now, and we can't get any other service to come into town at this time. But, I will reach out again.

Mary Jo Harris – of Family Guidance Center. Looking to continue the work that DJ started, service training and some adjustments needed to be made. Council President Tersigni said to submit it to the Clerk and I set the agenda, the Councilman can look at it.

Joan Pierce, 119 Lewis Street. I am here for an answer for the Fulton/Lewis street stop sign. A child is going to get hurt. Council President Tersigni stated he would have the ordinance drawn up. Mrs. Pierce said it has been 6 – 7 months ago and everyone is pushing it off. Council President Tersigni stated no a lot of corporation. Mrs. Pierce time to get along and worry about the kids. Council President Tersigni should have the Ordinance Mrs. Pierce it's our kid's lives, Stan Shrek that's who I will wait for.

John Guthmiller, for a month straight I called the Mayor's office with no call back, to discuss handicap parking at the Pork roll festival. I got a letter from the attorney, I got a call from the Chief of Police, but the Mayor won't answer he totally disrespected us.

Council President Tersigni I would have called you back. Mr. Guthmiller – DPW cut the grass and didn't pick up a pizza box they stepped right over it.

Dan Boyce, 244 Irwin St., service electric shows up at the footballs games. Councilman Davis stated it's written in the agreement, that they don't supply the equipment. Councilman Fey 2% of the bill we are getting short changed for it. Dan Boyce I am baffled about losing \$100,000 from the sewer treatment plant.

Council President Tersigni stated the disposal business; this is where they get septic, \$100,000. Move the skate park to the other park what's that cost. Dan Boyce said they are going to legalize POT the new Governor, I don't understand moving something already bought and paid.

Blaine Fehley, Bowhay, I have a question – the meeting is televised, lets' get to the bottom if it. 48,000 they provide broad cast. Councilman Davis as Council President knows we secured the software, but since we are moving Council Chambers, we didn't invest in the equipment – when we have a primary home we can invest in the equipment. Blaine Fehley – people keep paying. Councilman Davis the agreement is a percentage of the money goes to service electric. Blaine Fehley no on TV, the school channel-nothing on it. No advertisement \$48,000 a year up to ten years. Councilman Piazza to Councilman Davis the borough of Emmas the meetings I saw on Del Val has it – we have argued about this the past eight years.

Councilman Davis said it is something to think about.

Jim Kleiner, 318 Ohio Avenue, I want to discuss about the Municipal Building Move, on October 03, 2017 you passed a lease agreement with the BOE stated Mayor Ellis that an environmental study was done on October 05th, but 34 days later no formal report but yet 1/3 of the municipal building has moved. I appreciate the go ahead to find a place. If there is a hazard 5 art a para 1 – NJSA 34, employees 34 days not shared that there are any recognizable hazards. Noe one more box should be moved I don't understand.

Councilman Piazza – conditions of the report were satisfactory. Councilman Davis execution of the lease was contingent on it. Councilman Piazza should be moving. Councilman Lutz equipment has been professionally cleaned.

Jim Kleiner questioned is their radon?

Councilman Lutz which building Freeman?

Council President Tersigni this moving has been a debacle for over a year now. The school is not ADA and has asbestos, reports it stinks from the employees, Town employees and citizens report should be submitted to Council President and the Council. They put the cart before the horse – seems to be this administrations way. Councilman Piazza agrees on that issue.

Jim Kleiner administration has a responsibility to the employees; Council has a responsibility to the public, the schedule the entire building to be moved in to Freeman. OSHA/PEOSHA will cost the tax payers more, it is immoral and unconscionable.

Meliss Paulus, 26 A Glen Avenue in light of these issues for the last six months the risk manager should attend the meetings.

Council President Tersigni risk manager, insurance potential and liabilities, the CEO the employees and officials actions taken and not taken. He made a valid hostile environment with potential litigation problem and I am not paying for it.
