PARKS, SECTION 12, COASTING REGULATIONS, OF THE CODE OF THE TOWN OF PHILLIPSBURG TO INCLUDE WALTERS PARK was introduced for a first reading by Councilman Davis who moved that the ordinance be properly advertised. The motion was seconded by Councilman Fey.

Discussion: Open to Public – Bill Timmann – what are you going to do with the skate park, people use it now – why would you shut it down? Councilman Lutz – people think Riverside is a rat hole, soccer, bikes, boards, if you take it away down there then what do they have, there is a path it is open why change, can't even have a wagon in Walters park.

Council President Tersigni after thinking about hat the kids will get in trouble if they have something less to do; an idle mind is the devils works shop my Grandmother use to say.

Councilman Piazza where are they moving it too? Councilman Lutz stated the tennis courts.

Councilman Fey stated he spend a lot of time and met with contractors to get quotes to get the parks up to standards, and it was put into the budget to get done one park at a time, we have already allocated the money, it should have been done by now.

Bill Timmann kids go back there – on Market Street it is overgrown, cars are coming from other places, it is being utilized there now, so it should be left alone.

Council President Tersigni whose job is it to get his done? The CEO of the Town

Councilman Davis stated it is just allowing bikes in Walters Park; the Town did approve the Open Space referendum. Please remember what you're voting on.

Joe Meyner – the park is good – take their scooters to the sidewalk, open the bathroom in the back, vote it down.

Robert Fulper, vote down, Kelly Sheedy to bring it to Walters Park, this would open it up for is to be moved even though it isn't stipulated – that she move it. Chiefs not here but he will soon be. Please consider taking it down.

Councilman Piazza, withdraw

Pete Pisello moving the equipment costs, does anyone know the costs? By moving it you leave a dilapidated area – we have all these little pocket parks – (neighborhood) instead you want on giant park. If we rehab the current park and make it more attractive. If you take

the skate park out what will happen as when - PAL came out the weeds grew, it was a nice park and the money can be better spent to make it attractive.

Dan Boyce is it a money issue? Walters Park, Delaware Park has concession stands, have the recreation director work those stands to improve the condition of the parks, it is embarrassing, there are gully's and holes in the field. I was a PAL coach; maybe we can use some of our resources available.

Council President Tersigni stated Councilman Fey did a lot of work and nothing got done.

Councilman Fey money was approved, local contractors and never gotten or given the go ahead, one would have been done or at least scheduled by now.

O2017-31 Ordinance designated three way stop on the Fulton side street. Councilman Piazza made a motion; the motion was seconded by Councilman Lutz. The motion carried a 5-0 vote.

Dustin Pierce, 119 Lewis Street, should be a mandate that the Mayor is here, he should know what's being passed or not – maybe he had an emergency. The police Chief and Engineer do a report once a month, regarding the crime rate, DUI'S and the stop sign situation. We need to get a mandate.

Council President Tersigni stated he is just a guest we can't change the form of Government.

Dustin Pierce the CEO business has to go, this is not a business, and the Mayor is the Administrative head.

The Mayors secretary – I heard was the assistant Deputy Mayor, 18% over a long period of time that title needs, reflected in the Salary Ordinance.

Dustin Pierce asked about the paving of Hudson Street

Councilman Lutz stated that work was done and no paving can be done for a year things need to have a chance to settle.'

Dustin Pierce asked why can't there be a police officer at every meeting.

Council President Tersigni stated that I made a request to Chief Stettner and he did provide an officer.
