RESOLUTION CANCELING AGGREGATE AN \$820.410.90 AMOUNT OF SEWER UTILITY **IMPROVEMENTS APPROPRIATED PURSUANT TO** ORDINANCE NUMBERS 2001-13, 2003-01, 2009-13 AND 2012-08 HERETOFORE ADOPTED BY THE TOWN OF PHILLIPSBURG, IN THE COUNTY OF STATE OF WARREN. NEW JERSEY. AND **RETURNING SUCH CANCELED APPROPRIATIONS** TO THE SEWER UTILITY CAPITAL IMPROVEMENT **FUND** 

**WHEREAS**, Sewer Utility Capital Ordinances Nos. 2001-13, 2003-01, 2009-13 and 2012-08 (the "Ordinances") were each duly adopted by the Town Council of the Town of Phillipsburg, County of Warren, New Jersey (the "Council"); and

**WHEREAS**, there are currently remaining, funded improvement authorizations in the aggregate amount of \$820,410.90 under the Ordinances (as detailed below), which are not necessary for the respective purposes for which they were authorized in the Ordinances, as applicable; and

**WHEREAS**, the Council now desires to transfer such \$820,410.90 from the Ordinances to the Sewer Utility Capital Improvement Fund so that such moneys shall be available for other necessary Town sewer treatment plant improvements;

## NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL IN THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN, STATE OF NEW JERSEY, AS FOLLOWS:

**Section 1.** The unexpended balances of the improvement authorizations as provided in the following Ordinances, aggregating \$820,410.90. shall each be canceled and transferred to the Sewer Utility Capital Improvement Fund, as follows:
