A RESOLUTION OF THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN, STATE OF NEW JERSEY, APPROVING A CHANGE ORDER FOR THE PURCHASE OF A NEW FIRE PUMPER

WHEREAS, the Town of Phillipsburg is under contract with Pierce Manufacturing for the purchase of a new Class A Fire Pumper with a Class B foam system and 50 foot telescoping waterway; and

WHEREAS, after meeting with the vendor, reviewing the prints for the vehicle, and meeting with the Engineering Department, the Fire Chief has requested two change orders to the contract; and

WHEREAS, the Fire Chief has recommended approval of the following change orders:

- 1) Change Order #1, the following items are deleted for credit
 - 2.5 inch foam bypass for Snozzle \$1,256
 - Side upper cab Whelen #600 warning lights (2) \$549
 - 2.5 inch foam tank drain \$762
 - 120V shoreline outlet \$215

Total Credits in the amount of \$2,782;

- 2) Change Order #2, the following items are to be included as an additional cost
 - Whelen 500 LED warning lights, body upper sides front (2) \$478
 - 1.5 inch foam tank drain \$653
 - Switches at pump panel and rear body for rear scene lights \$210
 - Air clamps with S/S covers for ladder rack \$560
 - Recess foam inlet and discharge valves at pump panel \$470
 - Pull straps for side roll up doors with side loop retainers \$800
 - Lighted safety handrails, cab doors \$400
 - Lighted safety handrails, rear body \$470
 - Pink pole tubes in transverse cab compartment \$280
 - Compartment pull out floor mounted storage trays (2) \$1,824
 - Two additional FRC 12V LED scene lights, rear sides, upper body \$3,950
 - Three handholds in rear of hosebed dividers \$180
 - Retractable West Coast style mirrors no charge

- Shorten upper rear facing crew cab storage compartments no charge
- Move front bumper discharge to top of bumper with swivel connection no charge
- Lift and turn latches for SCBA compartment doors no charge

Total additional costs in the amount of \$10,275; and

WHEREAS, the additional costs of change order #2 in the amount of \$10,275 are offset by the credits of change order #1 in the amount of \$2,782.

NOW THEREFORE IT BE RESOLVED by the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey, that the above-mentioned Change Order # 1 and Change Order #2 are hereby approved increasing the Contract amount previously awarded to Pierce Manufacturing by a total of \$7,493.

BE IT FURTHER RESOLVED the new proposed contract price is \$722,516.43.

BE IT FURTHER RESOLVED that sufficient funding is available based upon certification of availability of funds by the Town's Chief Financial Officer.
