AN ORDINANCE OF THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN AND STATE OF NEW JERSEY RENAMING "MERCER STREET PARK" TO BE KNOWN AS THE "JESSE DELGADO RECOVERY PARK"

Section 1.

WHEREAS, Jesse Delgado was a lifelong Phillipsburg resident who resided along Mercer Street and who, subsequent to its construction, spent many hours at the Mercer Street Park; and

WHEREAS, Jesse Delgado was an inspiration to many as a coach, mentor and friend; and

WHEREAS, Jesse Delgado fought courageously the demons of addiction, having experienced periods of recovery followed by periods of active use, a pattern which is so common to those afflicted with the disease; and

WHEREAS, Jesse Delgado tragically lost his life to the disease of addiction, despite his courageous fight against it; and

WHEREAS, the Town Council has previously acknowledged the stigma associated with the disease of addiction; and

WHEREAS, the Town Council believes it important to recognize that the disease of addiction is real and that those who are afflicted by it are people from all walks of life and further, that the disease does not recognize class, race, economic or social status; and

WHEREAS, by renaming the Mercer Street Park the "Jesse Delgado Recovery Park" the Town Council believes it can both recognize and honor the life of Jesse Delgado and at the same time call attention to this important issue, both the disease and the stigma attached to those who suffer from it.

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Phillipsburg, County of Warren and State of New Jersey that the Mercer Street Park shall henceforth be officially known as the "Jesse Delgado Recovery Park" and commonly referred to as "Delgado Park" and that signage reflecting the name change be erected and installed under the direction of the Office of the Mayor.

Section 2:

<u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.

Section 3:

<u>Repealer.</u> Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed as to their inconsistencies only.

Section 4:

<u>Effective Date.</u> This Ordinance shall take effect upon final passage and publication as provided by law.

WHEREAS, based on the evaluation from the Business Administrator and the office of Community Development upon reviewing all submittals and associated costs; it was determined that Happy Software had the best software for the department's needs; and

WHEREAS, MRI Software LLC, submitted a proposal dated July 31, 2021, to provide Happy Software services for an annual support cost of \$14,046.43; and

WHEREAS, the value of these services shall not exceed \$14,046.43; and
