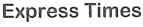

PLEASE TAKE NOTICE, that on Thursday, June 23, 2022 at 7:00 PM, in the Town of Phillipsburg Housing Authority Building, Community Room, 535 Fisher Avenue, Phillipsburg, New Jersey 08865, a public hearing will be held by the Town of Phillipsburg Land Use Board to consider a request for preliminary and final site plan and variance approvals (Section 625-32: off-street parking – 18 parking spaces required, none existing or proposed onsite; de minimis exception from the RSIS for parking deficiency) and such other variances, relief and/or waivers that may be deemed necessary by the Board in connection with the Application submitted by the Applicant/Owner, 43-45 South Main Street LLC, for the property located at 43-45 South Main Street, Block 903, Lot 47 on the Tax Map of the Town of Phillipsburg. The Applicant is proposing to convert the existing 4-story building into a mixed-use building consisting of approximately 1,553 square feet of ground level commercial space and a total of three 2-bedroom residential units above with associated building improvements and signs. The property is located in the Riverfront Redevelopment Area – District 2 (RRA-2) Sub-area 3 (Main Street).
