PLEASE TAKE NOTICE that on Monday, November 21, 2022, at 7:00 p.m., AVANTOR PERFORMANCE MATERIALS, LLC (the "Applicant") will appear before the Town of Phillipsburg Land Use Board (the "Board") for a public hearing concerning its application for preliminary and final site plan approval with bulk variance relief on land designated on the Town of Phillipsburg Tax Map as Block 101, Lot 5, with an address of 600 North Broad Street ("Property"). The Property is located in the Town's in-

The Property is located in the Town's Industrial - Heavy (I-2) Zone District.

The Applicant seeks to install a canopy mounted solar facility over an existing parking lot and adjacent grass areas at its existing industrial facility. The Applicant requires the following bulk variances: (1) front yard setback (35' minimum required, 4' existing and proposed); (2) side yard setback (30' minimum required, 10.32' existing and proposed); and (3) maximum hedge height (up to 4' permitted, 7' proposed). The Applicant will also seek any additional variances, waivers, or exceptions identified by the Board or during the course of the hearing.
