Joe Meyner – 392 South Main Street

Spoke to R2022-241 Affordable Housing Trust Fund Spending Plan, 2.5 million – Bldg. 125 units – who and when. Noted initial cost – Admin cost of 20% thought high. Continued, O2022-34 – FOG, Fats, Oils, Grease and noted very thorough.

Attorney Wenner spoke to R2022-241 and noted Town collects monies from Projects and a portion of the monies are earmarked for the Affordable Housing Trust Fund Spending Plan. He shared example of Bridge pays to TOP required amount to go towards the spending Plan; which must go to affordable housing – rehabilitating dilapidated buildings – 20% State statute.

Tax Assessor, Craig Brotons noted up to 20% of Total Budget.

CP Wyant stated R2022-241 is similar to our RCA Program – the Regional Contribution Agreement Program.

Tim O'Brien, Engineer – the design allowed for a switch in product; which is accepted industry wide and used by Contractor in past Projects.

Cnclman Piazza stated, then it is an industry standard. Added going forward are we looking for completion in May? Hoping Parks Programs are being mapped out way in advance so as not to be caught scrambling last minute.

Cnclman Piazza introduced subject of skateboarding groups, Lehigh Valley Bladers. The Town Facility – skateboard park not being used, fallen into disrepair. Not enough upkeep – added, people will travel for these type of staples – Recreation, Tourism and Safety/Lighting needed.

15. PUBLIC PETITIONS

Ms. Genser – 481 Pursell Street

Spoke to truck traffic on Center Street – (3) schools in area affected – asked please do not allow truck traffic.

Tim O'Brien, Engineer spoke to Center Street truck traffic, noting the State requires a connection to Rt.22 – Center Street or South Main Street. Continued, TOP does not want Center Street to be Truck route, but if State does not allow – Town would entertain, if State comes back with Center Street could adopt/reject. Do not go road by road – had to develop plan and left with State for review. Adding, must consider Center Street, but not preferred choice.

Cnclman Piazza noted to limit 95% on TOP roads – South Main Street, north.

CP Wyant stated ultimately comes back here. We could do nothing – if Council doesn't want. We have asked State for exception.

Cnclman Piazza stated as it is currently, trucks can use any street.

David Morrisette 5 Fairview Heights

Spoke to Center Street – Truck Route and noted if comes back Center Street or don't do anything, please don't do anything. Thanked TOP for following advice of State – can use Skate Park. Questioned if Recreation Director can be paid by Referendum dollars. Thanked CP Wyant and Randy Piazza, Jr. for vote regarding O2022-30. Continued, CP Wyant recused himself as an owner of Property within 200' of the Howard Street Project. Noted as Piazza Jr. grew up on Mercer Street and has made mention of father still living there, meaning he has family member living within 200' and appears conflict regarding vote.

Dan Boyce 1526 Warren Street, Alpha Spoke to past election and trespass – upset property owner regarding signs.
