RESOLUTION AUTHORIZING EXECUTION OF LEASE AGREEMENT BETWEEN BROTHERS BEFORE OTHERS AND THE TOWN OF PHILLIPSBURG

CP Wyant had Resolution pulled to discuss, as the Lease Agreement was not part of the Agenda; which was posted on the Website for the Public. He continued by saying he had problem with the Resolution and not with the Brothers before Others Organization, noting there should be a balance with the Parking. Noted when he was Mayor and before, residents could park in front of their homes on N. Main Street. Decision was made to eliminate the parking spaces and put in a sidewalk to allow safety from traffic, the concession being the Municipal Parking Lot; which had 7 spaces. He continued feels not fair all those spaces be taken from the residents – going back on what was agreed and cannot in good conscious vote for approval of Lease. He is a no Vote.

VP Clark stated he remained quiet during discussion as he had been advised by Town's Attorney to recuse himself from the vote because he had been given a ticket to the Turkey Brawl sponsored by the Brothers before Others organization and this has created a conflict – transparency, not voting on this Resolution.

Cnclman Marino stated in regard to transparency – never rec'vd anything from the Brothers before Others organization. Also commented that did not see any of the UEZ proposals until today and yet discussing them tonight. Noted the Organization does great work and he will be voting yes.

Cnclman Piazza noted leases do change. Vote for the greater good 100 spots - 7 spots relief, does a lot for the Community. Serves a broad spectrum of people in, voting yes.

Cnclman Kennedy would have preferred Lease Agreement had been part of Agenda posted on Website. Recognizing all the organization does for the Community.

He continued it was explained why not possible due to the surfaces not conducive to those with disabilities and the Miracle League has a field (close proximity in Palmer Twp.) Also stated, initially not in favor of Peron Warehouse (taking heat), but changed opinion knowing need to move forward.
