CVP Fulper motion to open the hearing, CM Piazza seconded the motion – the motion carried a 5-0 Vote

Auditor Heidi Wohlleb-Nisivocchia – no tax increase despite significant shortfall of revenue. Received approval from DCA to adopt Budget tonight.

D. Morisette – 5 Fairview Heights

Please fund Library 740k, if you support this Budget, can't say you support Library.

D. Schneider- 26 Meadowview Dr., Lopatcong Twp.

Cut-off last comment – said saving 260k if approve 2021-136 purchase agreement. This does have to do with Budget, let may say question, then decide.

Cnclman Piazza noted the Lopatcong TC meeting from January 2021-mins/video with Agenda; which Ms Schneider stated were not on website are there. Added if she had question, to review the Lopatcong video and reach out to Lopatcong Township.

T. Chapman – 362 Brainards Rd., Harmony Twp.

Noted didn't think appropriate to censor comments.

CP McVey asked if about Budget?

T. Chapman stated previous speaker asked about Budget.

CP McVey responded, not Budget question, but rather question regarding last Resolution.

VP Fulper stated Ms. Chapman – out of order

Emil Brisson – 94 Bullman Street, Phillipsburg

Urged Council to fully fund Library. Wanting long term commitment from Mayor/Council, for stability going forward. Would hope support Cnclwmn DeGerolamo in November and put funds toward Library and not somewhere else.

Closed Public Statements

Council speaks to Budget

Cnclman Wyant – This is a tight Budget, kept rate flat. Down Police Officers, DPW also – everybody has to tighten belt, Library included-wishes had more money for Library and hire for Public Works and put officers on the street. Feel did well considering Pandemic, hopefully coming year/better year.

Cnclwomn DeGerolamo – Stated many parts to Tax bill, County, TOP, Open Space, Library and School, asked residents take notice as per school board meeting believes 1.5% increase of School Tax. Town of Phillipsburg rate remained flat. Noted any excess funds- between Pool/Library, would choose Library every time. Open to all/free to all-does not require paid membership-open all year. Would like to move forward tonight with this Budget.

Cnclman Piazza – Stated likes Budget Mayor presented. Able to keep flat – a lot less Revenue. A lot of other Depts. have taken a hit these past 2 years. Some provisions later this year, currently waiting to hear back from-think Library had Special meeting-they have some add'tl funds at their disposal, if not mistaken. With cutting our salaries able to give Library add'tl 35k over what Mayor has given Library and add'tl 5k to Senior Center, those 2 areas needed a little bit more than what originally given.

VP Fulper – noted Budget process daunting. Stated in terms of Library, had offer on table last week, believe Mayor made motion for Board to spend 160k to save employees. Continued did not know if accepted, having not heard back. Library not only department cut or hurting as Cnclman Piazza noted. Cnclman Wyant noted no new garbage trucks/street sweepers. Spent 200k and 218k on top of that, stated number Director Krolak asking for unreasonable. Disagree with Mr. Morisette – feels Library is fully funded.

CP McVey - Stated Budget is 19 million. Good Budget, noting first 2 years as Councilman did not have support of Administration, extremely difficult – Mayor did not attend Budget meetings. Mayor Tersigni submitted good Budget - Council worked collectively – kept Budget flat this year. Unsung hero, BA Benjivenga working with CFO Merlo and all departments with Mayor Tersigni, who does attend Budget meetings, making it much easier for Council to make decisions. Library – save comments for Open Time. If get behind just one department – Inspections – new Code Official. When November comes we all have concerns, but this is sound Budget – will talk it out. Keeping it flat is amazing.
