15. **DISCUSSION**

Funding of Library – Referendum

Councilman Piazza spoke to the subject of removing the Library from the Municipal side of the Budget and putting the funding of the Library to a Referendum. He continued, it makes more sense to put out to Referendum and ask the Public if they want to raise it. Adding, the Mayor provided a compromise this year of 131k, but this still fell short of what Library says it needs. Noted every year this becomes an issue for the Departments managed under the Municipal Budget. Stated this would create better planning allowing more focus if the Budget is set. Moving TOP long-term steady Plan.

CP Wyant asked for any other comments.

Councilman Marino noted, agreed with Councilman Piazza. Adding, put out to Referendum and let the people decide what to spend.

VP Clark agreed should go out to Referendum, noting he and Councilman Kennedy ran on it. Added, in speaking to Mayor, disagrees with removing the 131k this year. Noted former Library Director, Deb Messling said Library needed 500k. Stated, Mayor met at halfway to keep open and function. Feels needs to stay open for our residents. Added, redevelopment of our Town, the Library is key. Stated 2008 Library's funding was taken away. Noted we need to make sustainable – money going to OUR library, become self-sufficient.

Councilman Piazza asked BA Bengivenga what the numbers were last year. He responded 555k. RP noted this year at 680 – up 130k, adding went up 180k in the past 2 years, 525k originally.

CP Wyant stated, we were left with a deficit from the Federation, went to the County – leaving a huge hole. Been trying to supplement the Library Budget little by little with smaller increase. If we do this, go to Referendum, it will increase taxes to TOP residents. If taxpayers want to fund Library, put on ballot. Agree Library is a pillar of our Community.

Councilman Kennedy agreed should go to Referendum. Adding, yearly this becomes a crisis as to how to Fund the Library. Noted, put in the Public's hands.

VP Clark noted, Library Director Dave Krolak was on meeting and asked if CP would allow him to speak.

CP Wyant agreed to allow.

VP Clark appreciated.

Dave Krolak, Library Director – thanked Mayor and Council for the compromise of 131k; which allows the Library to remain open Monday through Friday for 8 hour days. Noted the Library is essential for the residents of TOP. Stated not only for use of computers, but printing, copying. Most especially to receive Professional help with Resumes, job search and many Programs made available. Continued, the Library is an absolute gem and if we are looking to enhance the Town's reputation we need the Library. Added he is available to answer any questions, just email him.

Councilman Piazza asked what is most popular book, Harry Potter?

Mayor Tersigni stated worked with Library to arrive at bi-partisan compromise for the 131k. Also, like Councilmen believes should go to Referendum.

CP Wyant noted should move forward with Referendum.

Attorney Wenner stated before Draft – the question is specificity of number, $1/3^{rd}$ of million? Went to CFO asking what increase ought to be. Adding are we going to fully close the gap and have zero on the line item? Library director, Dave Krolak and Mayor could provide work session in May? Stated will go forward as directed creating Resolution to present for adoption.

CP Wyant stated his understanding to totally remove from the Municipal Budget.

Cnclman Piazza noted his intention also.

No other comments.

16. Public Petitions

David Morrisette – 5 Fairview Hghts.

Noted, do we have amount County would charge? Referendum considered when County first pulled out 2016, heard 600k, former Cnclwmn DeGerolamo had said 300k. Once number figured our from County, know what we are looking for. Noted thinks the penalty being paid to the Library Federation is misinterpreted. Stated in agreement if County pulled out – Town would owe nothing. Feels Town Council should rescind paying penalty back. Added as Attrny Wenner knows – 1 party always gets punished, hope stop paying back.

Robyn Coe Donaldson – Stewartsville Questioned where to go to find Library's Budget?

CP Wyant state at the Library.

Ed Bullock Warren Street

Late to meeting, wanted to respond to Robyn. Stated, call Library Director Dave Krolak – he will share Budget. Stated he supports PFPL – value of it.
