14. <u>NEW BUSINESS</u>

Cnclman Piazza stated Phillipsburg Senior Center's ceiling in need of repair. Quite high/vaulted. Continued, may need Professional Services of Stan Schrek, Engineer. Quotes for work needed. Noted a Town Building maybe a Capital expense – quite a bit to deal with.

Mayor Tersigni noted – did ask Executive Director Bill Spencer to obtain Quotes, adding Engineer could check out and asked BA Bengivenga to make note.

CP Wyant stated, would like to work with Senior Center – get specs for dropped ceiling, continued should not be too big of job, don't feel need of Engineer for dropped ceiling.

Cnclman Piazza noted Mr. Spencer brought up something about Range Hood.

CP Wyant responded not in Main Room; which is 14' high and could benefit from ceiling being dropped and new lighting, save on costs to heat/cool. Asked Attorney Moscaguiri if need to go out to Bid? Or something Senior Center can do?

Attorney M. – noted could be something Senior Center could do on own, but wanted to run by Attorney Wenner before giving green light.

BA Bengivenga stated as long as Public Funds are not expended.

CP Wyant felt should hold off discussion until Attorney Wenner's return and advice on how to proceed. Continued the funds/donation received from McWane Ductile not Public Funds and could be used.
