14. NEW BUSINESS

Attorney Wenner putting Library on Referendum on ballot is a process and requires Ordinance, 1st and 2nd reading – Public Hearing.

CP Wyant suggested discuss at Work Session, sooner than later – April 12.

Cnclman Piazza noted Referendum on this came up before. Voted on, end of August, waiting periods. Added if not for Library, put through Budget. Adding Library has tried to reduce their request, still unable to meet.

VP Clark stated, would like to invite members of Library Board to WS, noting it is virtual.

CP Wyant noted it is met with taxpayer dollars regardless if coming out of Municipal Budget or separate.

Cnclman Piazza reiterated, fight always going to be there to take from other departments to satisfy Library. Continued Library Tax should be separate from Municipal Services.

Mayor Tersigni stated discussed with new Councilmembers, came up with compromise this year. April dealine ballot – agrees with Referendum.

Councilman Piazza moved to void agreement with Stateliner regarding Riverfront. Motion was seconded by Councilman Marino.

Attorney Wenner stated would prepare Resolution for next meeting to remove Stateliner as Redeveloper.

Questioned any consideration from Council regarding Rent Control being discussed at a Work Session?

CP Wyant stated will be discussed at a future work session.

GR – noted, also on Historic Preservation Board – questioned if any funds for Historic Preservation.

Cnclman Piazza, said yes in Budget.

Mayor Tersigni noted allocated \$2k for Historic Preservation Commission and contact BA Bengivenga with any questions.

CP Wyant stated, waiting for RT Environmental will need to assess condition. Just passed resolution for Contract tonight. Once receive results will take action. Must remediate building regardless.

445 James St. LLC Planning Board Application – requesting waiver from requirement to install curbing.

CP Wyant stated, seeking waiver regarding curbing/sidewalk. Continued, any new construction requires curbing/sidewalk.

Cnclman Piazza – wanted to clarify – asked if originally more unites were intended. Adding would not curbs help keep water from other properties?

Engineer Tim O'Brien wanted to clarify. Applicant – sidewalks on all roads – (3) roads include an alley. Continued as part of Planning Board received – can't waive, part of Ordinance. Currently there are NO SIDEWALKS. On alleys – side and rear alley. Discussion should be not to install sidewalk on side and rear alley. Currently Mulvay – no sidewalks, Webster-no sidewalks. Seeking relief not to install.

Mayor Tersigni commented, aware of Property. Used to own, 125' x 127'.

Cnclman Piazza noted, didn't they want 3^{rd} house – turned down. Curbing, run-off – do need curbing – people on Columbus. A lot of run-off – into James. Believes there should be curbing there.

TO'Brien noted Planning Board would either tell install or seek Council.

CP Wyant stated never required sidewalks on the alley.

TO'Brien – Molevy, Webster off Wilbur, Sayre.

CP Wyant stated curbs, but not sidewalks.

Cnclman Piazza – Planning Board meetings – concerned – too narrow for sidewalks, but curbing necessary.

CP Wyant noted, let's move forward, but need clarification – required for sidewalks-never alley. Due to water problem, need curbing.

TOB – Webster Street – rear alley and Mulvey – side Alley. Talk with applicant's attorney.

CP Wyant, straighten out next meeting. Curbing needed – not sidewalks, except James.

Cnclman Piazza – would like to include in future WS – BID – Melanie Thiel, Business District organization from Washington, NJ. Mary Jo Harris, part of 5 year NPP Plan-will reach out for dates and get back to CP Wyant.

Cnclman Marino – spoke to attending 2 Workshops, February 5 and March 12 was regarding Budget. Found both very informative. Energy Tax to State/to Municipality. Reval/Reassess. Questioned work being done on Heckman as work was done just last year – 5 year Moratorium?

Mayor Tersigni noted, the utility knows they are on the hook to repave entire road. Curb to curb, with no cost to TOP.

Cnclman Marino noted there is often flooding at Wilson/Heckman – feels it should be addressed.

Mayor Tersigni noted, would make Engineer Tim O'Brien aware.

Cnclman Marino asked if an Energy Plan in place if fuel continues to go up?

Mayor Tersigni stated, willing to discuss anytime-Open Door

VP Clark congratulated Phillipsburg Youth Corp – 120k Grant. Climate resiliency Program along the Delaware River. Phillipsburg Youth Corp Director, Mike Muckle, instrumental in running of successful Program. Continued, Downtown Association – new officers, along with Councilman Kennedy and Mayor Tersigni – all working together, new website TapInto former Councilwoman Degerolamo.

Cnclman Piazza – Thanked Administration for honoring Women's Month. Also congratulated PHS Wrestling Team/Staff.

Cnclman Kennedy – thanked Mayor Tersigni for mentioning St. Patrick's Day event at Shappell Park – raising of Irish flag. Cnclman Marino, Mayor, town residents and Hibernians present.

CP Wyant – noted Grace Lutheran Church having Yard Sale and asked Council to waive the Permit Fee.
