## 15. PUBLIC PETITIONS

## Elizabeth Ridley – 198 Summit Avenue

Spoke to Senate Bill – 1474 providing protection for warehouse/temporary workers who face lack of safety and other long overdue protections. She noted that Doug Steinhardt, voted no to this legislation – though he was a proponent of the warehouse project on Howard Street. She asked if there was a status to the cold storage vendor initially interested in the Howard Street Project? Also asked the status of Cal Ripkin Athletic fields project.

CP Wyant responded he did not know the status of the cold storage/warehouse project.

Attrny Wenner stated he was recently in touch with Chuck Brady/Cal Ripkin Project, who stated great strides being made in fundraising. Added on track for success.

ER – thanked for the immediate professional response by the PPD and Lopatcong PD's response to the false emergency's regarding the Phillipsburg High School. She continued by noting the large warehouse fire in West Easton – and their fire department's trouble accessing water. Questioned the fire prevention plan regarding the warehouses in TOP.

CP Wyant responded, our Fire Chief must approve all plans.

# Stuart Ridley – 198 Summit Avenue

Spoke to Executive Session Meetings and when the minutes would be made available to the Public.

# **David Morrisette – 5 Fairview Hghts.**

Spoke to Howard Street Warehouse Project, 142k square foot facility, would generate 183,456 truck trips onto New Brunswick Ave., Pohatcong Township within (1) year. Asked Council to consider impact and reconsider passing any Ordinance regarding this Project until pending lawsuit is resolved.

## **Ann Davis** Lewis Street

Spoke to Recreation Advisory Committee and the former Recreation Director stating no reason to have meetings with the Committee. She felt he was disrespectful of those on the Committee and disappointed the Mayor allowed it. Stated former BA Benjivenga had (1) meeting with them. Continued this is why people don't want to get involved/volunteer.

Cnclman Kennedy noted he had discussion with the new Recreation Director, Mr. Noel who plans on having meetings with the Recreation Advisory Committee.

## 16. COUNCIL OPEN TIME

**Cnclman Marino** noted different parts of TOP – alleys behind Warren and Bullman – where Garbage used to be collected, not being collected now – residents need information. He then asked Attrny Wenner if lawsuit against the TOP, who represents and at what cost? Attrny Wenner responded, generally deferred to Insurance carrier, 50k deductible.

**Cnclman Kennedy** – Stated, Saturday, April 8 will be the Exchange Club's Egg Hunt at 8:30 AM at Maloney Stadium – good weather expected. Wished all a Happy Easter.

**VP Clark** – Noted, April 13 – UEZ dinner will be held at River of Life Church. Discussion of funds and what used for. Also mentioned NAACP Gala – April 29<sup>th</sup> – supports scholarships to all races. Wished all a Happy Easter.

**CP Wyant** – stated the Relay for Life will be held on April 29 with a rain date of April 30<sup>th</sup> – to be held at Walter's Park. Spoke to problem of atv's, dirt bikes, recent bad accident involving dirt bike on Howard Street. Continued PPD can monitor, try to locate, but cannot chase. Hoping Ordinance suggested by Mayor may be way to handle going forward.
