7. PRESENTATION

REGAN GROUP, LLC

Larry Regan addressed the audience regarding their Vision Plan for a Workforce Housing Redevelopment for the 5.42-acre parcel located at 150 Fleming Drive (formerly Anderson Street). He appreciates Council inviting them to introduce their conceptual plan for the site and giving their input.

Gregg Stires, Civil Engineer noted early in process, 80-90 unit three-story building. Noted the entrance/driveway directly across from Firth Street. Hoping for second entrance on Warren Street – all Conceptual at this point. Parking in front and rear. Stormwater Management – backside, anticipating access to foot bridge and the park. Noted right across from Elementary School, currently in negotiations for Contract with owner. Open to ideas Public/Town Board.

Discussion

Cnclman Piazza – starter families – can see the need, those with small children. Location between Elementary School and the Firth Youth Center with services to families with after school Programs. Location lends itself to provide for young families. How Many 1, 2, 3 bedroom units?

Larry Reagan - Planning 20% 1 Bedroom, 20% 3 Bedroom and 60% 2 Bedrooms. Affordable to families, those coming out of College but not ready for own home. Affordable, Green built, new housing to provide for those working at new jobs resulting from Bridge Project. Those earning 30-80k annually. Not Public Assistance/Section 8. Individuals, couples and small families — don't want or need house, but first want to rent space well managed.

Cnclwmn DeG- Asked if there would be fees, like Condo – added on top of rent?

LR – Answered no. Renter responsible for heating/cooling – electric, own utilities. Water would be included in the rent.

Cnclwmn DeG – noted just apartments, how many floors?

LR responded, three floors, but all open to Planning Board.

DD – commended Mr. Regan for coming before Council and presenting tonight. Adding some buy and ask forgiveness after. Thanked for coming before Council ahead of Planning Board.

CP McVey – noted he had several conversations with Regan Group prior and had read their Letter of Intent at previous Council meeting. He added what a nice property right next to Town's crown jewel, the Walter's Park. He wished them well in the Process going forward. Noted he felt with Council's reaction to Presentation felt comfortable advising to move forward in going to Planning Board.

Attorney Wenner asked block/lot for record. Engineer responded Bl:1803 Lot:1. He noted motion should come from Council to direct Planning Board as subject property – non-condemnation.

CP McVey stated hoping for those interested to respond quickly, giving opportunity for review and ability to make appointment before term expires, to provide easy transition for PHA.

CP McVey noted hoping for assessment from Code Official prior to August meeting to be informed to make decisions.

10. MAYOR'S AND ADMINISTRATIVE OFFICERS

Mayor's Report read by BA Benjivenga - Town of Phillipsburg's first Pride Event was a huge success. We look forward to making next year's bigger and better.

The Town has applied for NJDOT road grant for Green Street from Center Street to Pursell Street.

The Mayor met with Rathi Niyogi of Stateliner United whose team and partners are working towards redeveloping Union Square Waterfront area guided by the Town's redevelopment plan for the area. This was a promising meeting with Rathi, and they discussed Stateliner United's vision and progress for the redevelopment project and its impact to community. They also discussed items of concern that have been raised by the members of the community; which include parking, truck traffic and access to the river & boat launch. All these issues will be considered and reviewed by Stateliner and Town professionals as the formal design of the project comes together. We are looking forward to working with Rathi and the Stateliner United Team, the community of Phillipsburg and the Town's Redevelopment committee as this project progresses through all the required steps.

Easton has been chosen to host part of the 20th Anniversary of the tragic events of 9/11 on September 4, 2021, and Mayor Panto asked us to be part of the ceremonies which include a parade that our Police, Emergency Squad and Fire Departments will participate in. The Never Forget Walk will highlight a day-long event schedule followed by a parade down Northampton Street honoring our first responders. The parade will start at 11:00 a.m. and end at the circle with a brief ceremony. Please come and honor these first responders for their brave and courageous help on that tragic day 20 years ago, and to remember all those who lost their lives.

CP McVey stated attended NPP/South Main Street alliance meeting on June 24. Well attended, productive meeting.

CP McVey noted he attended a Downtown Association meeting – it was very productive. Continued, confident moving forward things will only get better. Stated met with Rathyi – one of stakeholders, Stateliner and while downtown was able to introduce to Mary Jo Harris – had healthy, robust conversations. Grateful for by chance meeting.

11. PUBLIC DISCUSSION ON AGENDA ITEMS

Joe Meyner – 392 South Main Street

Spoke to 2021-176 stating the redevelopment of Union Square will completely destroy the Phillipsburg we know and love and McVey and Lutz will be responsible. Asked if O2021-16 if the 2.7 million was principal or % and part of the Budget.

DD – responded, all in the Budget.

Keith Kennedy – 898 Hill Street

Spoke to R2021-176

- 1. RFP Redevelopment rights transferring, who is principal?
- 2. Amount to invest
- 3. Sub-committee notes available to Public?

Attorney Wenner – responded USW is it's own entity – correct in terms of authority, Rights afforded to Stateliner are given to USW.

CP McVey – Estimated 80 million, acquired 7 million – sub 1, 2 Sub-committee meeting – give updates.

Attorney Wenner – Stated, No formal request nor discussion regarding Pilot. Adding that does not mean there might be a request in the future, but not at this point.

Derek Lewis 298 Morris Street

Appreciates seeing items online. Likes to see Progress in Union Square. Questioned R2021-176, asked who owns all of impacted properties and if any were Town owned? Added, were we prepared to use Eminent Domain. Asked about a Green Acres Meeting held in April of 2021 – Union Square – Red house.

CP McVey responded we know who owns – in Subsection 1. Responded Eminent Domain was voted on and passed and can be used, but as of now it is not needed. Regarding the Boat Ramp/Animal Shelter-developer is not moving forward with that area. Town of Phillipsburg will keep/maintain.

DL asked if encumbered?

CP McVey noted Sub 1-we own Parking Lot, if Developer wants to extend they could. We would move out RFP's-Planning Board. R2021-176 – Sub Area 1.

Attorney Wenner – stated Planning Board – still in process of Eminent Domain – not formalized yet, but looking to see if should be.

CP McVey – Preliminary stages – no discussion of Pilot at this time.
