Attorney Wenner stated Bl:1209 Lot:2 otherwise known as 277 Warren Street had been scheduled to be heard at the TC Meeting of October 5, 2021. Since there was no representation for the Property nor our Code Official continuation till tonight. Present is our head of Inspections Department/Code Official, Jack Daniels.

Jack Daniels swears to the Oath. He continued the inspection he conducted was only the outside of the Property. He noted the initial complaint was May 26 and he has made several visits since. Servicer of Note – Cyprexx.

Property in disrepair – complaint includes

- Tree in yard took down electric box off of building
- Basement well open hazard
- Posted as unsafe received cease and desist from family member on deed
- Unable to access but view from window, filled with personal items, water damage ceiling
- Food debris mold-dampness
- Yard water reservoir mosquito breeding place
- Deck falling apart

Attorney asked if could be rehabbed.

JD – cannot be determined without access. Structure needs a lot of work, roof, plumbing. Don't know if water has been turned off. Noted received email from Jane Dugan, who represents the bank as the Service Company. Someone is taking care of yard, but kitchen window open today, leaving property unsecured.

Attorney Wenner asked, is property a detriment to the health, safety and welfare of the residents of Town of Phillipsburg? Continued, at a minimum with porch missing, trespassers could be injured?

JD- Stated first responders and the general public are at risk. Debris in the basement well, unsafe if responders had to respond to fire. Appears to have removed oil tank, smell of oil, don't know if some leaked, don't know if cleaned up. Mold on stove and cabinets.

Attorney Wenner asked if danger structurally?

JD replied, don't know, but likely if roof has water infiltration. Continued ceiling falling, could have rott in floor joists, but need to expose to be sure, but witnessed the ceiling is coming down.

RW – asked if signs of vermin, feral cats.

JD - No

RW – asked minimum to bring it to no longer be a danger?

JD – New Roof, porch system, deck attached on side. Clean yard, but interior, no idea

RW – you observed water damage?

JD – Need to have all personal effects removed – gut to framing to determine if feasible to repair.

Attorney Wenner noted the Property is in foreclosure and lender is required to register property as Vacant/Abandoned and pay necessary fees. Acting Clerk Loudenberry was asked to check on registration.

Councilwoman DeGerolamo – Asked if basement slab – woodframe, clapboard – just in need of paint?

JD noted presume it is a full basement, uncertain.

Councilman Piazza – asked if it was a faint smell of oil?

JD – Responded no strong smell. Continued there was a Permit for tank removal; which is closed – assume tank gone, but didn't clean up, hard to tell.

RP – Asked where saw collapsed ceiling?

JD - kitchen.

Attorney Wenner had Mr. Daniels review and explain all photos he had taken of property; which were in Council's packet; which Mr. Daniels went into detail in doing so. He continued by stating:

- Danger to health safety welfare
- Unabated will worsen
- New roof needed
- Missing porch
- Structure fixed or moved
- Clean out Property
- Expose joists for rot/vermin
- Water in pond removed

JD responded yes to all listed

JD continued proper notices given UCC – unsafe 05.26.2021, issued to Mary Marczi – received a cease and desist from agent Donna Marczi. Sent by certified mail – indicates received on 06.01.2021, but no signature due to Covid.

RW – Stated notices given – non-compliant.

Councilman Wyant asked if DPW could be authorized to drain the pond-appropriate action.

JD – responded would try to get Cypress Service to do.

Attorney Wenner addressed Council citing best approach would be serve ten day notice – served to owner of record, service agent and any lien holders. Continued, Council has option to:

- 1. Do nothing
- 2. Order repair
- 3. If repair not done demo and place lien against property for cost
