7. HABITABILITY HEARING – 165 Hudson Street – Block 813 Lot 52

Attorney Wenner stated previously heard in October. Representation of service, Kyle Lacey, TLOA, LLC asking for extension of time, directed to appear tonight.

Kyle Lacey, Real Estate Asset Mgr., TLOA Servicing, LLC.

Attrny Wenner asked Council if any questions.

VP Fulper asked what steps have been taken? Neighbor been dealing with this since May.

KL – Had under Contract twice, fell through. Got quotes for roof moving forward to fix, we will fix.

Cnclman Piazza – understand you are hoping we will give promise not to demo, but this Habitability Hearing is regarding the current condition of the Property. When you sell then you can make the conditions.

KL – Stated, we will handle now.

RF – neighbor been subjected to deteriorating condition, first complaint made in May.

KL – Didn't know anything about Property in May.

Attrny Wenner stated order given for roof to be replaced within 35 days of October meeting. Council has right to these options:

Do nothing

Give extension of time to repair

Action due to non compliance – demo

RF – asked if move to demo, could order be rescinded?

Attrny Wenner responded, yes could be done. Demo would be issued/recorded against property – if roof replaced – could be rescinded. Asked Mr. Lacey what timeframe for work to be commenced and then completed.

KL noted received Quote on Friday; which was accepted and they are moving forward.

RP asked how long Quote good for?

Attrny Wenner stated, Inspections Dept head, Jack Daniels in audience and asked him to weigh in on situation. Attrny Wenner reminded JD he previously took oath and remains sworn in.

Inspector Jack Daniels stated extensive damage to roof, feels sheathing will be necessary – permit needed. Roof rafters may need to be replaced as well. Asked how long before KL pulls permit?

RW – asked is December 7 enough time to pull permit?

JD stated yes, assuming application is complete.

RF – move to demo, unless pull permit and begin before December 7.

JD stated history of Property. Complaint 5/28. August 4, posted unsafe structure. Ordered representatives to address/secure building as whole. No action until recently. No permits have been pulled. The porch must be addressed as well, just plywood over joists. Property is being marketed-people have entered, even though posted as unsafe. Disregarded our orders. Damage continues to increase.

RF continued to remind KL, you don't live there, have not had to endure. Move for demo, with understanding to rescind

Attrny Wenner – stated if the demands can be met – will you rescind.

KL – completed or commenced, what can we do?

JD asked can you make application tomorrow, we can have permit ready in 24 hours

RP added needs to move pretty far along

RF concerned neighbor should weigh in.

JD – went back to unsafe structure notice; which was read in to record previous time, October 19. Reading in what needs to be met by December 7:

Compromised roof

Front Porch – replace floor boards – unless structural/joists – then would require Permit for Porch also.

RF asked if porch danger to adjacent structure?

JD responded, no but to first responders. Adding there is a separation between the 2 properties.

Attorney Wenner stated due to Ordinance being subject of lawsuit, being reintroduced, adopted anew in light of any alleged irregularities. This will go to Land Use December 16 for Planning Review. December $23 - 2^{nd}$ Rdg./Final Adoption.

Cnclwmn DeG – Talked with developer, had recent conversations. They listened, spirit of wrong location. Industrial use, but unaware of Redeveloper's conditions. – would satisfy Rails, Trails, TOP – no cost of road work with understanding – change on that redeveloper conditional on Redevelopment Contract. Feel Public would be satisfied with more information. Crossing fingers – conditional, yes tonight.

VP Fulper – Agree with you, take exception with Howard Street thruway. Spruce up Parks – same page

HW – Still no from me. According to Public Notice from Land Use Mtg. – pulled from Agenda last night, still South Main Street via McKeen – proposing buying property to make turn. I am opposed.

RP – agreed would be hesitant if Howard Street extension not part of plan, but sure the extension will go through.

HW - 560-562 South Main Street are the proposed properties to be purchased. Even though wasn't heard at Land Use Mtg, have the Public Notice and the Zoom ID is wrong.

ML – Understand opposition for warehouse, but living in the area, something needs to go in there. There is acid, chemicals in the ground, knowing (3) big companies who build houses all said NO. What else can go there, but only if extension goes out to Center Street.

VP Fulper – backed since the beginning/ still glad Councilwoman had conversation with developer.

16. PUBLIC PETITIONS

Joe Meyner – 392 South Main Street

Mercer Street torn up, yet sanitary sewers not inspected. Councilman aware. Stated if you tear up road – must inspect Sanitary Sewer. Continued, Sanitary Sewer System – colossal risk to for TOP to continue to do just minimum. Inspection of sanitary system must be done over next 30 years, cannot ignore. If tear up should inspect.

Mr. Morrisette 5 Fairview Hghts.

State (2) things people of TOP do not want, businesses do not want tractor trailers – industrial district on riverfront – bad for downtown. Noted 150 Fleming Street – do not want an 80 unit housing. This would change the makeup to the single-family homes there. Also, asked, No Pilot-does not add to ratables. Need more single-family homes and extend Recreational Area.

Joan Pierce 111 Sitgreaves Street

Asked about curfew being enforced. Noted greater degree of vandalism apparent, bandshell at Walter's Park. Wondered aloud why Recreation Director DJ Kophazy no longer an employee of the Town. Disappointed, Mayor not responding to her phone calls and no one answering non-emergency #.

Lori Ciesla - Freeholder

Spoke to Broadband Symposium run by HUD back in October. Attended by Envision, Dr. Troxell among others to address problems regarding Broadband being available to all. Currently, rural areas having trouble, also cost prohibitive to many in TOP. Working to improve Broadband and make devices available to people. Continued, just attended League and noted how many other counties along the Delaware facing same. County Task Force – someone from TOP to address Broadband problem.

Kevin Keyser 563 South Main Street

Spoke to O2021-27 regarding the District 5, Riverfront Redevelopment. Stated lives across from Properties 560/562 McKeen Street. Understands those properties may be demolished to accommodate truck traffic. Stated can't lose Parking, already not enough. Also, children catch bus on the corner, safety issue. Stated, Say No on Warehouse. Thanked Councilman Wyant for voting no.

Dan Boyce 1526 Warren Street

Spoke to O2021-23 Stop signs needed, 5 episodes of children nearly struck. Solution may be to issue parking permits to park on Hudson Street, lined parking spaces. People don't know how to Park and take up (3) spaces.

Robyn Coe – on phone – connection difficulties Asked why voting again on warehouse Project?

Attorney Wenner explained, being re-introduced due to being challenged in Court. Alleging conflicts therefore voting anew.

VP Fulper – Stated legitimate concern of children at bus stops on South Main Street. Noted a process in place, must trust Planning Board.

Went on to speak to subject Joan Pierce touched on regarding the absence of Recreation Superintendent. Noted BA Benjivenga informed him 10/27/2021 of DJ Kophazy's resignation, added asked to reconsider – Mayor said would meet on November 3rd to address. Mayor told individuals he would keep DJ. Said he would meet/speak, but radio silence – then stated resignation would stand. During last (2) years – great strides made – improving quality of life, but very clear Mayor mistreated employees. Mistreatment of female employee, this person's daughter liked a post; which painted Mayor in negative light, insisted employee's daughter remove like of post. In CFO's office – slammed fist- mad about a Petition – claimed employee not on his side. Mayor telling people has just one more employee to get rid of. VP stated simply wrong to mistreat a woman, called for Mayor Todd Tersigni's resignation. Wanted to log position – pushed out Clerk, DJ and unnamed employee. Told not to fear, will provide his Testimony when the time comes.
