8. ANNOUNCEMENTS/PRESENTATIONS

Mayor Tersigni read a Notice of Special Recognition for Kaneia Cooper On May 24, 2023 at approximately 7:42 p.m., The Phillipsburg Police Department was dispatched to 9 Lewis Street on a report of a 1-year-old child who was unconscious and not breathing. Upon arrival, the child was found to be alert and conscious. The Phillipsburg Emergency Squad transported the child to St. Luke's Hospital Warren Campus for medical treatment. The child was ultimately released after being evaluated.

Family members explained that the child began choking while eating, resulting in a medical emergency. When the child became unresponsive, one of the family members immediately alerted next-door neighbor Ms. Kaneia Cooper to request assistance as it was known to the family that Ms. Cooper works in the medical field and could possibly assist with this incident.

Without hesitation or delay, Ms. Cooper ran to the aid of the child. Ms. Cooper assessed the child and began chest compressions and rescue breaths. A short time later, the child regained consciousness and began crying. Her quick actions and basic lifesaving skills directly contributed to the child's life being saved.

Ms. Cooper exemplifies our community's care and compassion for one another. To put it simply, Ms. Cooper answered the call from a child in distress, saving a life and bringing great credit to herself, her family, and our community. There is no greater deed than to save the life of another.

MAYOR'S REPORT

Finally, I'd like to take a moment to recognize the heroic efforts of Ms. Kaneia Cooper, who on May 24, 2023 saved the life of a 1-year-old child here in the Town of Phillipsburg.

- 475 South Main Street – Attorney Wenner stated this is a continuation of the habitability hearing held April 18, 2023. Pat Kays, Construction Code Official, stated he spoke with the property owner who cannot attend the hearing. Mr. Kays stated the owner received 2 quotes from contractors to repair the roof. Both contactors stated it was not necessary to replace the entire roof. The owner applied for a demolition permit and has cleaned out the entire structure. The door was not replaced but has been secured better. The owner has not installed smoke detectors. The roof soffits have not been fully enclosed, the sides are open but the framing to enclose them has been done. Attorney Wenner recommended a continuation of this hearing in one month. Councilman Piazza stated it is very important that the smoke detectors be installed.

11. PUBLIC DISCUSSION ON AGENDA ITEMS

Joe Meyner, 392 South Main Street, Phillipsburg – Mr. Meyner stated the selling price of Town properties sold at auction were too low and Council should not approve the contracts. He also spoke on Resolutions 2023-115 and -118 that the Town should invest in computer programming to handle revenue streams.

Meliss Paulus, 26A Glenn Ave, Phillipsburg – Ms. Paulus asked about the process for handicapped parking spaces and was told the application goes to the engineer and, once approved, goes to the DPW who forwards the request to council via a Resolution. Ms. Paulus stated there are residences with off-street parking that have obtained handicapped parking spaces and that is against the town ordinance.

Joan Pierce, Prospect St, Phillipsburg - Ms. Pierce stated that \$330,205 for improvements at Walter's Park is a lot of money for tennis courts. The money could be put to better use for the kids in town. She asked Council to review this again before voting on it.

18. PUBLIC PETITIONS

Joe Meyner, 392 South Main Street, Phillipsburg – Mr. Meyner stated the town threw away a quarter million dollars accepting the auction sale contracts of the town properties. Regarding Resolution 2023-118, why not hire a programmer to modernize billing and set up automatic flows to the proper accounts?

Dave Morrisette, 55 Fairview Heights, Phillipsburg – Residents in the triangle between North Main and Morris told him a person involved in the redevelopment discussions told them their buildings were going to be demolished. CP Wyant stated that the Council has not received any information about that occurring.

19. COUNCIL OPEN TIME

Councilman Piazza – has items he intended for New Business – He stated an updated rental property roster showing property owners/landlords and tenants/occupants would allow for the town to make sure renters were safe and in good homes. Councilman Piazza would like to see a Social Media Policy brought up again. The lack of a policy/guidelines doesn't allow the town to properly oversee postings. Our Insurance Company does have guidelines the town can use.

Councilman Marino – The town will be receiving grant money for walkways. He would like the town to establish a committee, appoint bipartisan members with expertise in the area and use the money to do something good for the area. Councilman Marino asked if there are any outstanding grants for which the town put down money up front but has not been paid/matched. Matt Hall will look into this. Councilman Marino stated he likes that the town honors residents. Mike Burke has done a lot for the town and Council should consider issuing him a proclamation.

Councilman Kennedy – noted that during Public Petitions many residents bring up negative occurrences and issues that overshadow the positive things happening in town such as: The Gunshot Detection system will have a positive impact on crime. The ribbon cutting was held for the new town pool. The Walking Tour along South Main Street where QR codes on the light poles allow visitors to learn about places of interest. The rehab of Union Station and the opening of the museum. The Ole Town Festival that just took place. The Open Air Market with new ideas and more vendors every Sunday. Tuesday night Cruise Nights at Joe's Steak Shop. The Concert in the Park Series on Thursdays starting next month in Shappell Park, The Railroad Festival in September, and The Pork Roll Palooza in October. We need to make residents and people outside of town aware of all these events. Phillipsburg has a lot going on and it is moving in a positive direction.

Council Vice President Clark – agreed with Councilman Kennedy and stated that all these positives help residents and developers see what is going on, they help improve the moods of residents, and help promote more good things. Council VP Clark added that the Library is holding its 100 year celebration tomorrow from 4:30 to 7:00 pm with lots of activities, and they will be holding a summer reading program. He thanked everyone who participated in the Little Liners Pie to the Face contest.

Council President Wyant – Phillipsburg had a great weekend with a lot of positive things happening and he is proud of all that is being done. It is important to focus on the positive, not the negative.
