MAYOR'S REPORT

October 3, 2023

I am pleased to announce that the groundbreaking of McWane Field at Walters Park will take place on Wednesday, October 25<sup>th</sup>, 2023 at 1:00 p.m. this is a huge achievement for our town and I hope to see you all there. Our pickleball and basketball courts continue to move towards full completion as well. Recently we received a much needed area in need of redevelopment designation for the former Norton Complex from the New Jersey Department of Community Affairs, and we've also received a proposed PILOT agreement from the developer of the former Elks building. Development continues to flourish in Phillipsburg. Preparations have already begun for the remediation of the Corliss Avenue building and we await the commencement of active mitigation work in mid-October.

I am also working with County of Warren on a comprehensive truck plan and will be presenting an ordinance to Council for passage at our next meeting.

As previously discussed, I've presented my appointees for the Open Space Committee, and I encourage Council to act upon the remaining vacancies this evening so that the Town can move forward with Green Acres

Lastly, when reviewing the UCR "Uniform Crime Statistics", there has been an increase of one crime "443 to 442" from 2022 to 2023.

#### 19. PUBLIC PETITIONS

-Ann Davis, 220 Willow St, Phillipsburg – asked if all the "match" funding for the Cal Ripken field has been secured. Administrator Hall stated there is no "match" for the town. Council is utilizing the \$300,000 Bridge had allocated for Recreation as the town's portion for the field. Ms. Davis asked for an accounting of MPP funds and how they are spent. CP Wyant stated she should contact Mr. Hall who can get the information from the CFO. She also stated there has been no Recreation Advisory Committee for over a year so there will be no appointment for the Open Space Committee.

-Matthew Scerbo, 1073 Pearl St, Phillipsburg – It is redundant for the Mayor to include encouragement in his report to appoint Open Space Committee members tonight when there has not been a committee in almost two years. The Mayor had championed cleaning up blight in town but along South Main St, the Ice House and old Agway site are still a blight after four years. As a gateway to the town, it would be a great place to start. The Mayor had a chance to sign off on the RAD program which would have demo'd the 1930's Housing Authority buildings and built new ones. Mr. Scerbo doesn't feel the town is doing a good job cleaning up the town.

-Stuart Ridley, 198 Summit Ave, Phillipsburg – thanked Council President Wyant for all he has done for the town, as Mayor, as a Councilmember and especially as Council President. He has brought a sense of decorum to the Council.

-Dan Boyce, 58 Sitgreaves St, Phillipsburg – asked that the Green Space dealings be voided as it is political grandstanding. There has been no Green Space committee for two years but a month before the election, it must be done now. One appointee had been removed from a youth organization and shouldn't be involved where children are involved. If it is not voided, "I will personally beat everyone in the head with the facts of what is going on".
