15. OLD BUSINESS – No Old Business

NEW BUSINESS – Tim O'Brien, Van Cleef Engineering – The Town will be applying for a **16.** DCA Resilience Communities Grant. Notice of the public hearing was published in the newspaper in English and Spanish as per the grant requirements. The grant is due Dec 15, 2023 and can be up to \$5,000,000. There is no match requirement, but it is a reimbursable grant. The public hearing is to allow the public and governing body to provide input on the application before submittal. The OEM has identified allowable projects, 7 of which are prioritized, based on the town's Hazard Mitigation Plan. The first project is stream stabilization along Lopatcong Creek which entails removing debris from the creek, banks, and stormwater outfalls to allow for freer flowing water, less flooding and to improve habitat quality. Another project is the former Agway property. The grant allows for the town's acquisition of properties in flood hazard areas, an area in which this is located. The next project is the purchase and installation of generators in emergency shelters, heating/cooling centers, and emergency operations centers, including DPW and firehouses. Another project is to reconstruct the Warren Street basin to meet current and future rain events and address water quality. The basin was last overhauled in the 1980's / 1990's and it is potentially undersized for future rain events. The next project is to replace the Mercer Street culvert that runs through Delaware River Park to alleviate and reduce flooding in the downtown area. The sixth project is the installation of backflow preventors along the Delaware and Lopatcong Creeks on the stormwater outfalls. The last project is to eliminate cross connections of stormwater and sanitary which result in additional flows into the stormwater system that can increase flooding risks. Mr. O'Brien asked for confirmation of the priority list from Council and any input from the public. At Mr. Wenner's request Mr. O'Brien stated the list of projects was compiled by the Administration, The Director of Community Affairs, the OEM, and himself and the order was determined based on the likelihood of each project receiving funds. Councilman Piazza stated another grant could cover the cross connections. Mr. O'Brien stated, based on council's prioritizing of projects, that may not be included in the grant application.

18. PUBLIC PETITIONS

-Ann Davis, 222 Lewis St, Phillipsburg – She had addressed council several weeks ago and spoken with Mr. Hall about getting paid for working the Open Air Market last year. She has been told several times she would get paid but has not been. Mr. Hall stated it will be on the next meeting. Ms. Davis asked for an accounting of NPP grant money and how it is being spent. She then asked what the normal turn around time is for obtaining a Certificate of Occupancy. Mr. Kays (audience) will look into the Certificate she needs.

-Ray Patt, 459 Kneedler Ave, Phillipsburg – Congratulated all the Rec teams that won championships.

-Robin Coe Donaldson, 44 Vernon Rd, Stewartsville – on behalf of the Downtown Phillipsburg Association (DPA), South Main Street was closed from Jersey to Stockton but work was only being done

by the park. Then one side of Stockton was closed. The whole area did not need to be blocked off. Businesses had zero traffic and a lot of them rely on walk-in traffic. DPA would like to be included in planning in order to help make things move better. CP Wyant stated the Police Chief is responsible for the road closures and he has asked him and the Business Administrator to work with downtown merchants because this has been a long term, ongoing problem. Administrator Hall stated they have met with utility companies to try to fine tune how they do road closures.

-Bill Benz, 39 South Main St, Phillipsburg – President elect of the DPA - at last night's Land Use meeting, information about changing the Master Plan included documents indicating Phillipsburg as a warehouse town. DPA is curious about the subjectivity of the nature of this phrasing and how it fits into the overall plan and when the Master Plan was changed.

-Levin Ellison, 147 South Main St, Phillipsburg – He provided a resource center for LGBTQIA children and youth in his former town. He noticed a lack of mental health resources for them across Warren County. The State Department is interested in his program. He would like his organization appointed the official host of Pride Celebrations.
