8. ANNOUNCEMENTS/PRESENTATIONS –

- McDonald's Sidewalk Waiver – Cherllynn Walters, Attorney for McDonald's, stated that over the last several months McDonald's engineers have met with Town Engineer Tim O'Brien and Town Attorney Rich Wenner to examine options for sidewalks along Memorial Parkway and Marshall Street. McDonald's will build a sidewalk along Memorial Parkway. They are requesting

a waiver for the sidewalk on Marshall Street. Ms. Walters stated the cost for each ADA compliant walk surpasses 20% of the cost of the underlying project which allows for an exception. McDonald's Engineer, Mike Deitner from Bohler Engineering, was sworn in by Attorney Moscargiuri. Mr. Deitner explained that if a walkway was constructed within the curb line along Marshall Street an extensive retaining wall would be required due to the slope to the street. An alternative plan to bring the sidewalk out into the street would create a safety hazard. Town Engineer Tim O'Brien stated that it is feasible to construct a walkway along Marshall Street. Some of the improvements shown by McDonald's are not within the scope of work. If the walkway were moved into the street the curbs would be realigned to mitigate the safety issues. He noted that regrading the slope along Marshall Street is needed for the entryway in the underlying project. Mr. O'Brien recommended that if the waiver were granted now, no future waivers should be allowed and that any future renovations must include the sidewalk.

CVP Clark asked how far out into Marshall Street would the sidewalk be installed? Mr. O'Brien stated 4 to 5 feet.

Councilman Kennedy asked how a sidewalk on Marshall is a hazard versus walking in the street. Councilman Piazza is concerned that non-resident drivers wouldn't be aware of the curb realignment and the realignment could cause problems with snow plowing. He feels having a sidewalk in the street is dangerous.

Councilman Marino feels drivers will hit the curb

Mr. O'Brien stated that similar realignment has been done to other streets in Phillipsburg. CP Wyant agrees that drivers will hit the curb.

CP Wyant asked for a **Motion** to grant a temporary waiver for the McDonald's Marshall Street sidewalk.

-NJ DCA Resilient Community Projects Grant – Public Meeting & Comment Period

Town Engineer Tim O'Brien stated the Notice of Public Meeting and Comment Period was advertised in the newspaper, posted on the Town website, and posted at the Municipal Building in both English and Spanish. The public can submit comments via email to him at tobrien@vancleefengineering.com that will be included anonymously with the application. The application is due by December 15, 2023. The grant will award up to \$5,000,000. The town will use their own funds for the project(s) and be reimbursed by the state. Mr. O'Brien stated the list of projects submitted at tonight's meeting was compiled by the Director of Municipal Services, the Emergency Management Coordinator and himself working with the Town's Hazard Mitigation Plan and are in order of priority and potential to be funded. He noted that no funds can be used for occupied residential properties. He then listed the potential projects:

- 1.Streambank Restoration & Stabilization of the Lopatcong Creek within/along Town of Phillipsburg to remove storm debris such as fallen trees and remove debris and restore areas disturbed by tree removal/cleanup efforts and repair of outfall stabilization. Mr. O'Brien noted that the cost is not generally covered by storm recovery grants/funds.
- 2. The Town of Phillipsburg is considering the acquisition of the former Agway Property off south Main Street. The property has been identified in the Master Plan as an "Area in Need of Redevelopment" and is located in a flood hazard area and represent fill within flood hazard area. Mr. O'Brien noted that a letter from the property owner is required, and any liens must be paid.
- 3. Purchase and installation of generator for emergency shelters and heating/cooling centers in the Town of Phillipsburg and emergency operation centers.
- 4.Reconstruction of the Warren Street Basin to meet the current and future rain events and address water quality issues. Mr. O'Brien noted this has not been designed yet.
- 5.Replacement of the Mercer Street Culvert to alleviate and reduce flooding in the downtown area. Mr. O'Brien noted an application for Community funds had been submitted but denied years ago and the cost is \$10,000,000.
- 6.Installation of Backflow Preventors along the Delaware River and Lopatcong Creek.

7.Elimination of cross connections with storm and sanitary sewer that result in additional flows in the storm system and increase the flooding risk downstream. – Mr. O'Brien noted that other funds may be available for this project.

Comments -

Councilman Marino – No comments

Councilman Piazza – Feels generators should be higher on the list than Agway.

Council VP Clark – asked for clarification that up to \$5,000,000 can be used and that the application can be submitted for less than that amount. Mr. O'Brien confirmed. He asked how many warming/cooling centers/ Emergency operation centers do not have back up generators? Mr. O'Brien did not have an exact count but believes it is 3. CVP Clark asked what the cost estimate is for the Warren Street Basin. Mr.

O'Brien stated the system would need to be scoped before that number can be determined.

Councilman Kennedy – Feels that the generators and flooding issues are most important.

Council President Wyant – Feels that getting a letter from the owner of the Agway property and handling the liens would take too long and that project should be moved further down the list. He stated the generators and Warren Street Basin are more important.

David Morrisette, 5 Fairview Heights, Phillipsburg – asked where the additional \$5,000,000 for the Mercer Street culvert would come from. CP Wyant stated the town would provide the additional funds. Randy Piazza, Sr., Phillipsburg, NJ – he agrees that the Agway property should be at the bottom of the list. There is an aquifer in that area.

Comment period closed.

Mr. O'Brien requested a motion authorizing him to submit the grant application.

Motion authorizing the submission of the NJ DCA Resilient Community Projects Grant Application with the list of discussed projects, with project #2 (Agway Property) moved to the bottom of the list.
