Old Business: Public Hearing on the Circulation Element Plan of the Town of Phillipsburg Master Plan. Town Engineer Tim O'Brien went over the request change that the Highlands requested. The change was made due to the truck routes and warehouse traffic. Public Comment on the report: Robin Coe is very concerned about the truck traffic on South Main Street where she owns a business. She said they are not a fit for tractor trailers. Building the warehouse will bring more trucks and she does not want anymore trucks. Ms. Morisette also does not like the truck traffic on South Main Street. She witnessed pedestrians almost being hit on that street. South Main Street is mostly residential, and heads need to be put together for pedestrian and car safety. Mr. Piazza Sr. asked Tim O'Brien, town engineer, if Highlands recommended or the state. Tim said it was the Highlands. Tim O'Brien mentioned that the DOT will not have trucks on South Main Street. Board Member Mr. Penrose asked if South Main Street is a State Highway and Tim O'Brien said it is.
