## 7. PUBLIC DISCUSSION ON AGENDA ITEMS

- Ann Davis spoke regarding Resolution 2024-19. She asked why the NPP funds were administered by NORWESCAP when the town has a Community Development Office that could do it. This would save \$40,000 over two years that could be used for other programs. Ms. Davis also noted that when she reviewed the NPP fund quarterly report recently there were discrepancies, notably the \$400 reimbursement check she had received was not in the report. CP Marino stated he will meet with the Business Administrator to discuss this.
- Dave Morissette spoke regarding the Housing Authority appointment. He stated that due to CP Marino having a sister who works with the Housing Authority and CVP Paulus having a "personal vendetta" against an employee of the Housing Authority, neither should vote on the appointment as this would be a conflict of interest. CP Marino asked Attorney Wenner to address this. Mr. Wenner stated that local municipal ethics law states the conflict of interest only applies to an immediate relative, i.e. a spouse or dependent, who resides in the same house. As this does not apply to either CP Marino or CVP Paulus both are able to vote on the appointment. Mr. Wenner cautioned Mr. Morissette about characterizing a person's motives as a vendetta as it could be construed as character assassination.
- Aaron Coleman spoke regarding Resolution 2024-19. He stated the questions he asked at the January 16 meeting have not been answered, he has not been reimbursed for \$3700 in receipts, and emails have still not been answered. Mr. Coleman stated that Resolution 2023-24 (referenced in the title of R2024-19) on the town website does not have a description of the agreement. He asked if it is the same agreement as the one in place? He stated it is a conflict of interest for any town employee to receive money from the grant. CP Marino stated that he will be meeting with the Business Administrator and Attorney regarding the NPP grant and will have information for Mr. Coleman by Friday. Mr. Coleman stated he sent his information presented at the January 16<sup>th</sup> meeting to everyone and he hopes they have taken it into consideration before they vote on R2024-19.

### 8. GREEN ACRES PUBLIC HEARING

Tim O'Brien, Engineer, Van Cleef Engineering detailed 4 grants available through Green Acres:

# Land Acquisition Program

- 100% grant funding
- Bond is available (30 years for 0%)
- Application would be to acquire lands related to Rails to Trails that are currently owned by Norfolk and NJ Transit
- Amount should not exceed appraised value
- Soft costs not to exceed 2% or 20,000 for engineering, legal etc.
- Grant amount \$1,400,000.00

# Park Development Program

- Grant up to \$1,400,000.00
- No match required, but bond is available for match
- Total project budget \$1,400,000.00
- Project scope improvements associated with rails to trails, previously fund \$1.3 million for
  estimated preliminary scope of \$2.1 million. Additional improvements and needs have been
  identified to be able to complete addition milage of trail, more extensive modifications to trails
  such as benches, wayfinding, theming, additional access points, traffic control features,
  landscaping

### Urban Park

- Grant \$500,000
- No Match
- No bond
- Mercer Street park
- Needs of the park overhaul of sports court, new fencing, add accessible route into park, expand play area to be more accessible, inclusive and comprehensive, replace swing structures and consideration for installation of play surfacing. It's anticipated the full scope could require municipal funding support, but scope could be narrowed to accommodate

### Jakes Law

- Grant up to \$750,000
- No match, but bond can build out a robust park
  - o 20 years at 0% cost per 100k is \$5K+
- Total project budget \$1,750,000.00
- Brainard's Park
- Inclusive accessible playground equipment including young age and pre-teen age, accessible parking and path to park and play structures. Preliminary estimate.

Mr. O'Brien stated that these grants would improve the quality of outdoor recreation for Phillipsburg residents, provide a positive impact in at-risk areas, and provide greater accessibility to a large part of the population.

### Council Comments -

Councilman Clark stated he is excited about this, and it is a great achievement for Phillipsburg Recreation. He will help with Open Space and Park Development.

Councilman Kennedy asked Mr. O'Brien if the Park Development grant could be used to restore the Morris Canal Arch. The arch is not safe but once restored it could be a great attraction. It is part of local history. Mr. O'Brien stated the grant does not provide for restoration.

Councilman Scerbo thanked Mr. O'Brien for the overview. He is excited about the playgrounds being upgraded for the children in Phillipsburg. He will work with Open Space and Council.

Council Vice President Paulus thanked Mr. O'Brien for explaining everything so well. She agrees with the other Council members that this will be a great benefit to the town. She will help with Open Space and Recreation.

Council President Marino thanked Mr. O'Brien for a great job and believes these upgrades will help bring back the downtown area.

#### Public Comments -

Janelle – asked Mr. O'Brien if there were any overlays or requirements for funding that have to be matched, or any requirements for additional monies beyond the projects themselves. Mr. O'Brien stated there is no additional funding on top of the grant amounts.

Mr. O'Brien stated that Council is required to pass the resolutions to submit the grant applications.

## 15. COUNCIL OPEN TIME

Councilman Clark – he is excited about the Green Acres grants. Regarding the Housing Authority appointment, Councilman Clark stated the original notice had a submission deadline in February, but without notification, that deadline was changed, and the public had no idea. The candidate is questionable and 2 of 5 Council members had issues with the appointment. He feels it is irresponsible.

Councilman Scerbo – questioned if prior appointments to the Housing Authority were advertised to the public. He stated the information was given to the governing body, not the public. Council Vice President Paulus – she attended a LEAD, Law Enforcement Assisted Development meeting and encouraged the public to attend the next meeting on Feb 21 at the Envision Center. She also encouraged people to visit the Winter Market and said the vendors and their products are all very good.

Council President Marino – given the volatility of some people these days, he will no longer require people to state their address when they speak at Council meeting. Their personal information should not be available for someone to find easily. He encouraged the Council to work together to move forward. While people may disagree, everyone should strive to tell the truth and work for the better of the community.
